13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. We propose to drill out the CIBP @ 5900' and clean the hole out to the original PBTD of 6213. After cleaning the hole out we Propose to test Three zones to determine the presense of Behind Pipe Reserves. These zones will be perforated, acidized with 1500 to 2500 gallons of 7.5% NEFE acid and swab tested separately. If Swab tests idciate the neccessessity for further stimulation, the zones will be fracked using 30,00 to 60,000 # of sand pursuant to service company reccomendation.

Proposed new Perforations:

Zone 1: 6002-6040
Zone 2: 5666-5688
Zone 3: 5602-5614

We expect this job to last approximately 2 weeks and the work is scheduled to begin between April 6, 2015 and June 30, 2015.

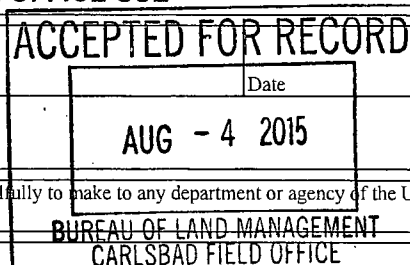
