Down hole pump was still good.

08/12/2015 Well pumped 12 bbls of fluid. Well was showing 1 to 5% oil cut. Well started tagging.

Well does not have a casing leak.

08/13/2015 Well lost pump action. Called kill truck to test tubing and dump fluid down the backside.

08/14/2015 Tested tubing and it held pressure. Pumped 35 bbls fresh water with soap down the backside. Got pump action. Well started pumping again.

08/15/2015 Allowed soap and fresh water to soak on formation. Suspected salt ring in casing.

08/17/2015 Lost timer switch on control box. Called electrician to repair. Well was pumping with good gas show. Well was cutting 1 to 5% oil cut.

08/19/2015 Well pumped 11 bbls of fluid with a 1 to 5% oil cut. Recovered 20 bbls load water.
