Mack Energy proposes to plug back and recompleat the Brook Federal #5 as follows.

Procedure

1. Notify BLM Lea County 24 hrs prior to commencing work. 575-393-3612
2. RU wireline & RIH shoot off tbg. Above packer @ 9297' we will leave packer in hole.
3. RU wireline set CIBP @ 9287'. Top of Wolfcamp @ 9287' *or SPOT 200' cement on top of packer*
4. Spot 25sx Class H on top of CIBP @ 9287' WOC 4 hrs & tag cmt.
5. Circ. 11# mud. Set 25sx Class H cement plug from 7587-7407', WOC and tag. Top of Abo @ 7497'.
6. Perform CIT to 1500# for 30 min. w/chart.
7. Perforate Yeso from 5400-7250' acidize swab and evaluate for frac.

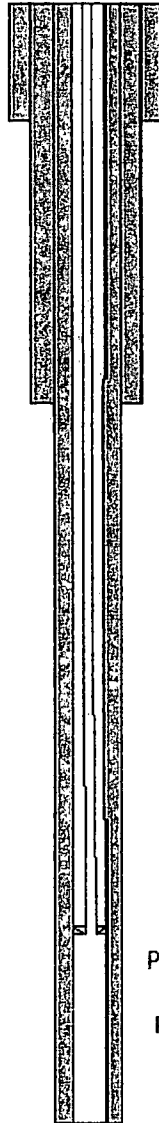
