09/15/15 RIH w/tubing and 12' muleshoe. Circulated hole w/mud laden fluid. Spot 35 sx cement @ 3612-2642. WOC. Tagged plug @ 2751. Circulated hole w/mud laden fluid. Spotted 50 sx cement @ 1400-704. (Ok'd by BLM to combine plugs).

09/16/15 Tagged plug @ 606'. Spotted 25 sx @ 350 to surface. ND BOP. Rigged down and moved off. Cut off wellhead. Pumped 25 sx cement between 8 5/8 and 4 1/2 casing per Pat McKelvey w/BLM. Moved off. 09/16/15 Moved in welder and backhoe. Dug out cellar. Cut off wellhead. Welded on "Above Ground Dry Hole Marker". Backfilled cellar. Removed deadmen and moved off.

Installed Closed-Loop System with steel tanks. Hauled contents from Closed-Loop System to approved NMOC disposal location according to Rule 19.15.17.
