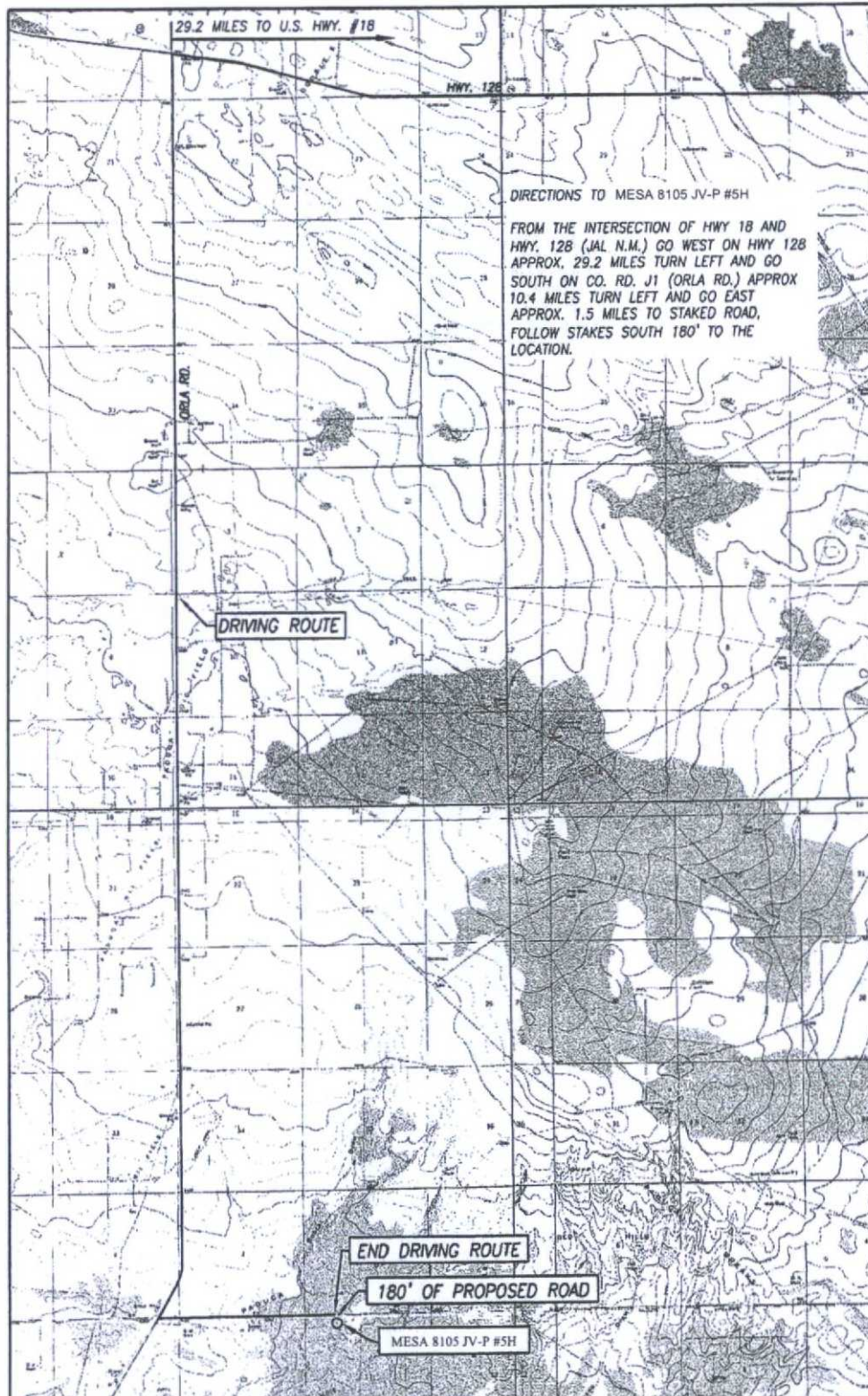

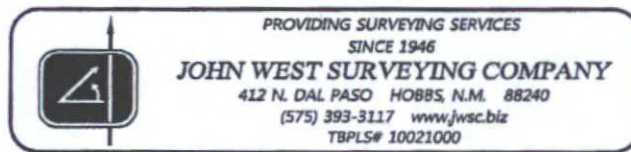
VICINITY MAP

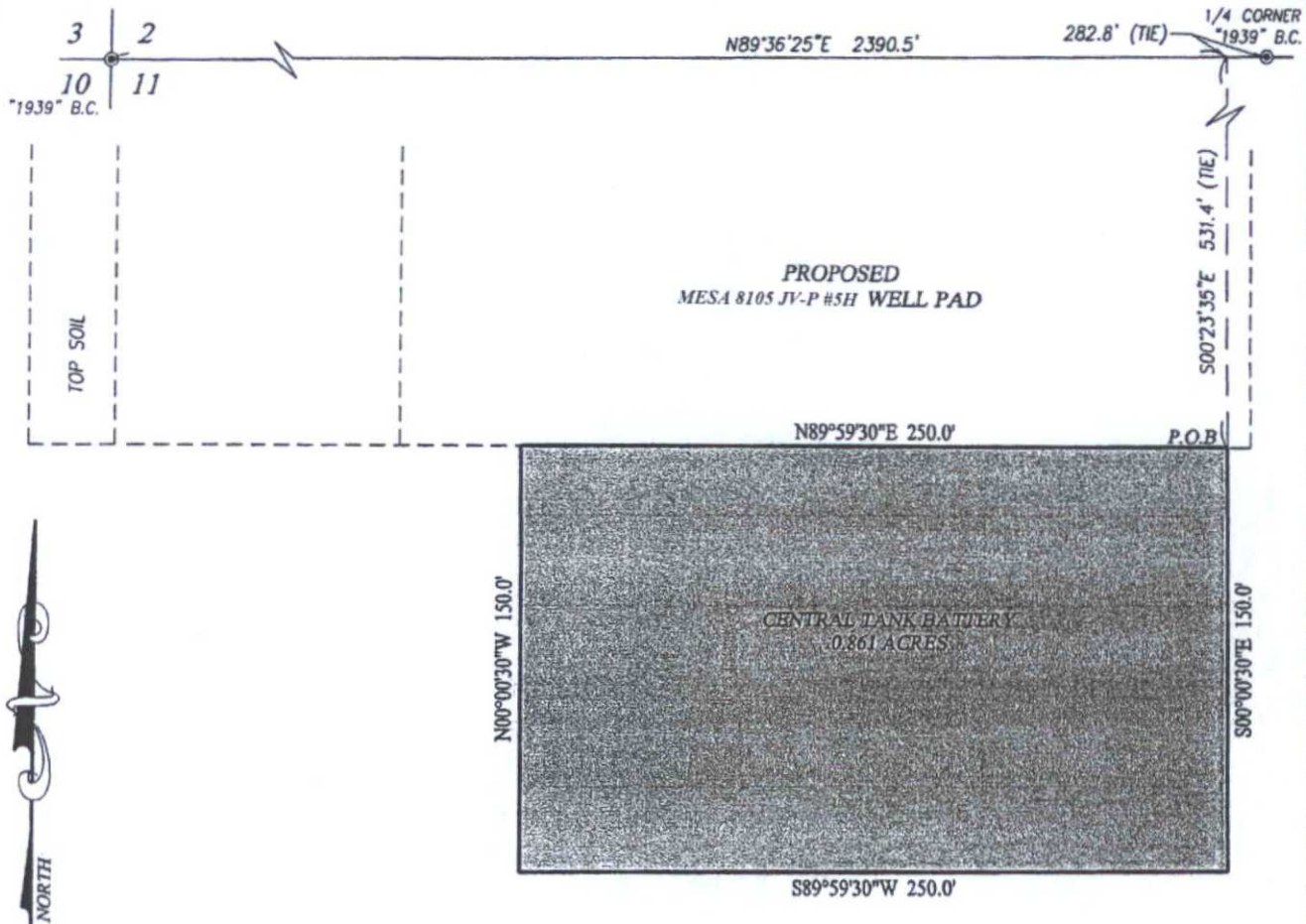
