Spot 100 sxs Class "C" Neat from 1150' - 1315'


Spot 125 sxs Class "C" + 4% CaCl₂ from 350' - 600'

Spot 25 sxs Class "C" Neat from surface to 60'. Witnessed by Stan Mayo of BLM.
