10-10-2014 Attempt back off 3 times at 3071' with no success. Free point and back off drill pipe at 2622'.

10-11-2014 Set plug #1, 173 sacks cement at 2622'. Wait on cement a total of 8 hours. Tag top of cement at 2501'. Paul at BLM approved bottom plug at 121' above fish and proceed with P&A. Pumped plug #2, 155 sacks cement at 1175'.

✓ 10-12-2014 Wait on cement a total of 12 hours. Tag with wireline at 1087'. Pump plug #3, 155 sacks cement at 1080' drill pipe measurement. Wait on cement 8 hours. Tagged top cement at 955', 95' inside the 13 3/8" casing. Talked with Paul at BLM at 11:45 pm Ref: cement top at 955'. OK to set CIBP at 953'. Set plug at 953'. Set plug #4, 96 sacks cement at 100' and circulated cement to surface.

10-13-2014 RDMO. Proceed with dry-hole marker and surface abandonment procedure.
