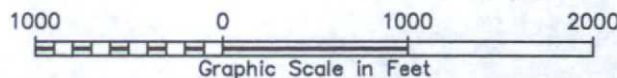

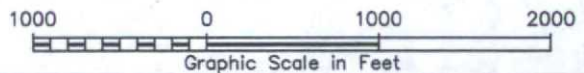

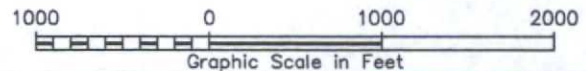
SECTION 12, TOWNSHIP 20 SOUTH, RANGE 34 EAST, N.M.P.M.

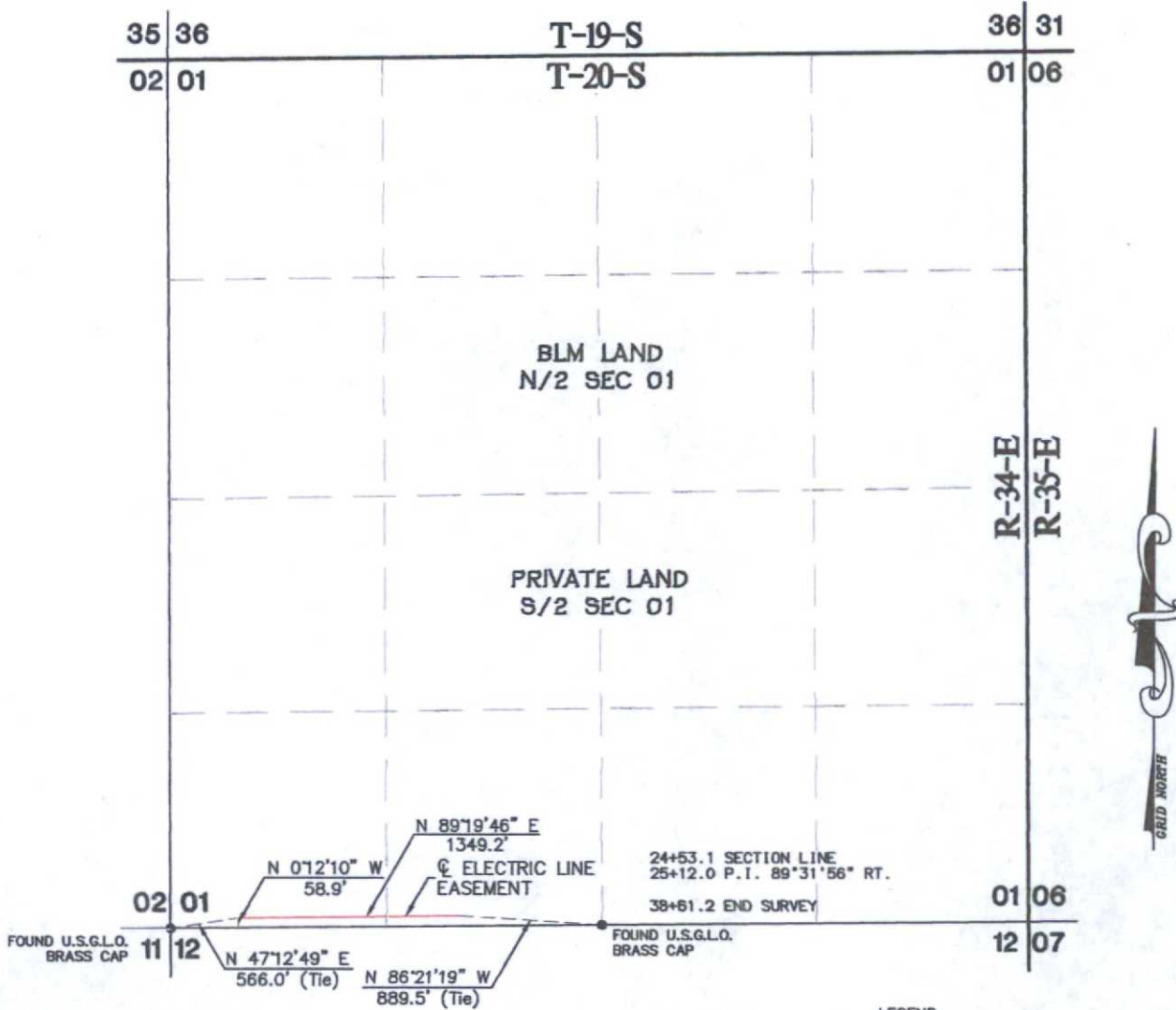

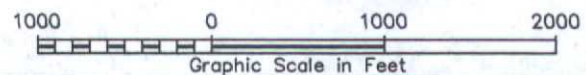
