100 ppm H2S concentration shall trigger activation of this plan.

RECEIVED

This is an open drilling site. H₂S monitoring equipment and emergency response equipment vill be rigged up and in use when the company drills out from under surface casing. H₂S nonitors, warning signs, wind indicators and flags will be in use.

- A. All personnel shall receive proper H2S training in accordance with Onshore Order 6 III.C.3.a
- B. Briefing Area: Two perpendicular areas will be designated by signs and readily accessible.
- C. Required Emergency Equipment:
 - Well control equipment
 - a. Flare line 150' from wellhead to be ignited by flare gun.
 - b. Choke manifold with a remotely operated choke.
 - c. Mud/Gas Separator.
 - Protective Equipment for essential personnel.

Breathing apparatus:

- Rescue Packs (SCBA) 1 unit shall be placed at each briefing area. 2 units shall be stored in the safety trailer.
- Work/Escape packs 4 packs shall be stored on the rig floor with sufficient air hose not to restrict work activity.
- c. Emergency Escape Packs 4 packs shall be stored in the doghouse for emergency evacuation.

Auxiliary Rescue Equipment:

- a. Stretcher
- b. Two OSHA full body harness
- c. 100 ft. 5/8" OSHA approved rope
- d. One 20# class ABC fire extinguisher
- H2S detection and monitoring Equipment:

The stationary detector with three sensors will be placed in the upper doghouse, set to visually alarm @ 10 ppm and audible @ 14 ppm. Calibrate a minimum of every 30 days or as needed. The sensors will be placed in the following places: Rig floor, Bell nipple, end of flare line or where well bore fluid is being discharged (Gas sample tubes will be stored in the safety trailer).

- Visual warning systems.
 - a. One color code condition sign will be placed at the entrance to the site reflecting the possible conditions at the site.
 - b. A colored condition flag will be on display, reflecting the current condition, at the drilling site.
 - c. Two wind socks will be placed in strategic locations being visible from all angles.
- Mud Program:

The mud program has been designated to minimize the volume of H2S circulated to surface. The operator will have the necessary mud products to minimize hazards while drilling in H2S bearing zones.

Metallurgy:

- a. All drill strings, casings, tubing, wellhead, blowout preventer, drilling spool, kill lines, choke manifold and lines, shall be suitable for H2S service.
- b. All elastomers used for packing and seals shall be H2S trim.
- · Communication:

Communication will be via two way radio in emergency and company vehicles. Cell phones and land lines where available.

12S Operations

hough no H₂S is anticipated during the drilling operation, this contingency plan will provide for methods to insure the well is kept under control in the event an H₂S reading of 100 ppm or more are encountered. Once ersonnel are safe and the proper protective gear is in place and on personnel, the operator and rig crew issential personnel will ensure the well is under control, suspend drilling operations and shut-in the well unless pressure build up or other operational situations dictate suspending operations will prevent well ontrol), increase the mud weight and circulate all gas from the hole utilizing the mud/gas separator ownstream of the choke, the choke manifold and the emergency flare system located 150' from the well. Bring the mud system into compliance and the H₂S level below 10 ppm, then notify all emergency officers that rilling ahead is practical and safe.

'roceed with drilling ahead only after all provisions of Onshore Order 6, Section III.C. have been satisfied.

anition of Gas source

should control of the well be considered lost and ignition considered, take care to protect against exposure to sulfur Dioxide (SO₂). Intentional ignition must be coordinated with the NMOCD and local officials. Additionally ne NM State Police may become involved. NM State Police shall be the Incident Command on scene of any najor release. Take care to protect downwind whenever this is an ignition of the gas.
