ConocoPhillips Company respectfully submits this subsequent report of interim reclamation activities and seeks further deferral of reclaiming two sides of the location.

We had requested deferral of interim reclamation to accommodate drilling of additional wells in 2015. However, that deferral has expired and our drilling plans postponed.

Reclamation has been performed on the east and south sides of location by: flipping the location, spreading topsoil around the reclaimed areas, and contouring to blend with surrounding area.

Existing infrastructure and future drilling plans prompt the request to defer interim reclamation of the north and west sides.
