Devon Energy respectfully requests approval of a battery change from the original Interim Reclamation Diagram in the approved APD for the Thistle Unit 52H.

Originally the APD stated the battery for this well would be located at the Central Tank Battery in Section 22, Township 23S, Range 33E. However, because that battery could not handle the amount of production coming to it from the Thistle wells, a second battery was constructed on the Thistle Unit #52H pad to handle half of those wells.

The wells currently routed or planned to be routed to the Sec 28 Battery in the near future are: Thistle Unit 51H, 52H, 53H, 59H, 60H, and 54H.
