12/14/15 MIRU plugging equipment. ND wellhead. NU BOP. Tag TD @ 2920'. Circulated hole w/mud laden fluid. Spot 25 sx Class C cement @ 2920-2680. POH w/tbg. Perf'd csg @ 1260'. Set packer @ 957'. Pressured up on perfs to 800 psi. Spotted 25 sx cement @ 1325-1085. POH. WOC.
12/15/15 Tagged plug @ 1098'. Pumped 20 bbls of mud laden fluid. Perf'd csg @ 365'. Sqz'd 40 sx cement w/3% CACL @ 365' and displaced to 250'. WOC. Tagged plug @ 244'. Perf'd csg @ 100'. Sqz'd 40 sx w/3% CACL and brought cement to surface inside 5 1/2.

12/16/15 Verified cement at surface. Rigged down and moved off.

12/21/15 Moved in backhoe and welder. Dug out cellar. Cut off wellhead. Welded on "Below Ground Dry Hole Marker". Backfilled cellar. Removed deadmen. Cleaned location and moved off.
Installed Closed-Loop System with steel tanks. Hauled contents from Closed-Loop System to approved NMOC disposal location according to Rule 19.15.17.
