Plugging Report

1/4/2016 Cleared road to location. Moved in and rigged up. Moved equipment to location. Installed BOP and Worked packer free. Started pulling pipe and the tubing tongs broke down. SION.

1/6/2016 POOH with tubing. Left handed back-off collar from the packer was on the end of the tubing. Pulled 85 joints. Packer was left at 2667'. RIH with scrapper to 2660' and POOH. RIH with 4 ½" CIBP and set at 3650'. Circulated MLF and spotted 50 sx class C cement on top of CIBP. POOH with tubing and SION.

1/7/2016 Perforated at 1000'. Could not pump into perms. Pulled packer and RIH to 1065' and spotted 25 sx cement. Estimated TOC at 695'. Perforated casing at 220'. Could not circulate or pump into perms. RIH to 282' with tubing and circulated cement to surface inside 4 ½" casing with 20 sx. Rigged down cut off well head. Existing cement was to surface between 4 ½" and 8 5/8" casing. Topped off 4 ½" casing and installed marker. Cleaned pit and cleared location.
