11/23/15 - Tested casing to 5500 psi for 30 minutes, good. Opened toe sleeve at 7000 psi. Pumped 1500 gals of 15 percent HCL acid and displaced with 3 percent KCL with corrosion inhibitor and oxygen scavenger.
12/6-12/15 - Perforated Bone Spring 9,590 ft - 16,550 ft (1400 holes). Acidized toe sleeve and perforated Bone Spring with 125,500 gallons 15 percent NEFE HCL acid, frac with a total of 10,465,588 lbs of sand.
