Perf'd csg @ 60'. ND BOP. Sqz'd 20 sxs from 60' to surface. Rigg'd down and moved off. 11/02/15 Moved in backhoe and welder, dug out cellar, and cut off wellhead. Welded "Underground Dry Hole Marker". Backfilled cellar, removed deadman. Cleaned location and moved off.
