Spotted 25 sx cement @ 1933-1563. RIH w/ packer, perf'd csg @ 900'. Pressured up to 900 psi. Spotted 25 sx cmt 957-587'. WOC. 10/29/15 Tagged plug @ 716'. Perf'd 4 1/2 csg @ 60'. Pressured up to 500 psi. ND BOP & wellhead. Sqz'd 25 sx class C cmt @ 60' to surface. Rigged down, moved off. 11/02/15 Moved in backhoe and welder, dug out cellar, and cut off wellhead. Welded "Underground Dry Hole Marker". Backfilled cellar, removed deadman. Cleaned location and moved off.
