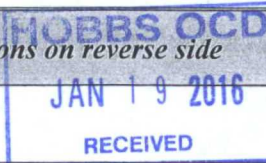

On June 17, 2009 SESI was onsite to perform clean up of staining from around dry well marker. The area was excavated to a depth of approximately 2" and 120 yards of contaminated soils was transported to an approved NMOCD disposal facility. The production equipment, storage facilities, and concrete pads were removed and transported to an authorized disposal facility. All abandoned surface and subsurface pipelines have been removed. The area was then backfilled with onsite soils from surrounding area and contoured to natural grade. The entrance to the access has been protected from vehicular travel by constructing a fence barrier to prevent entry on the road.
