Legacy Reserves Operating respectfully request approval for the current intermediate cement job on the subject well. The CBL indicates the top of cement is at 1736'. This is 65' above the 13 3/8" casing shoe @ 1801'. A successful 30 minute, 500 psi pressure test was performed on the 9 5/8" x 13 3/8" annulus; therefore the cement will provide adequate seal.
