We are in receipt of your BLM violation notice dated 11/23/15. We respectfully request an extension to the "Corrective Action to be completed by date" of 2/5/16 to 2/26/16. We DO NOT own the gas line or gas meter. We have been in contact with both the BLM & Sand Ranch Pipeline (owned by Rubicon Oil & Gas) to try and come up with an agreement on the pipeline. At this time the BLM is also working with Sand Ranch Pipeline. We request additional time in order to continue working with the gas line company to get this issue resolved. Our field superintendent has been working closely with Ricky at the BLM in order to get this resolved.
