Please see attached plat for flowline and gas lift pipeline routes from the Cascade 29 Federal #8H to the Cascade 29 Federal #3H bty.

Cimarex proposes to construct two 4" HP polylines one for gas lift and one for oil, gas and water production from the Cascade 29 Federal 8H well to the battery at the Cascade 29 Federal 3H.

Length of pipelines: 1792.47'

Both lines will be buried in the same ditch on the North side of the road.
