On April 5, 2012 a Notice of Intent was submitted to the BLM with regard to the proposed re-plugging of Government L Com No. 1. That sundry was approved on May 29, 2012 with an attached COA.

After further investigation and hearing, the NMOCC removed its requirement to re-enter and re-plug this previously plugged well due to technical unfeasibility and the distance and direction of the well relative to the Red Hills AGI No. 1. Therefore no work was performed. This Subsequent Report is submitted for closure of the 2012 Notice of Intent.
