CHEVRON IS REQUESTING A DELAY IN THE COMPLETION OF THE REMEDIATION WORK AT THIS BATTER UNTIL ALL WELLS UTILIZING THE BATTERY HAVE BEEN PLUGGED. PLEASE FIND ATTACHED A COPY OF WELL. KALEB WEAVER HAS DISCUSSED WITH JIM AMOS REGARDING THIS SITUATION.
