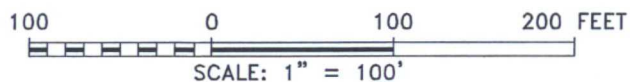

## Location Schematic and Rig Layout for Closed Loop System

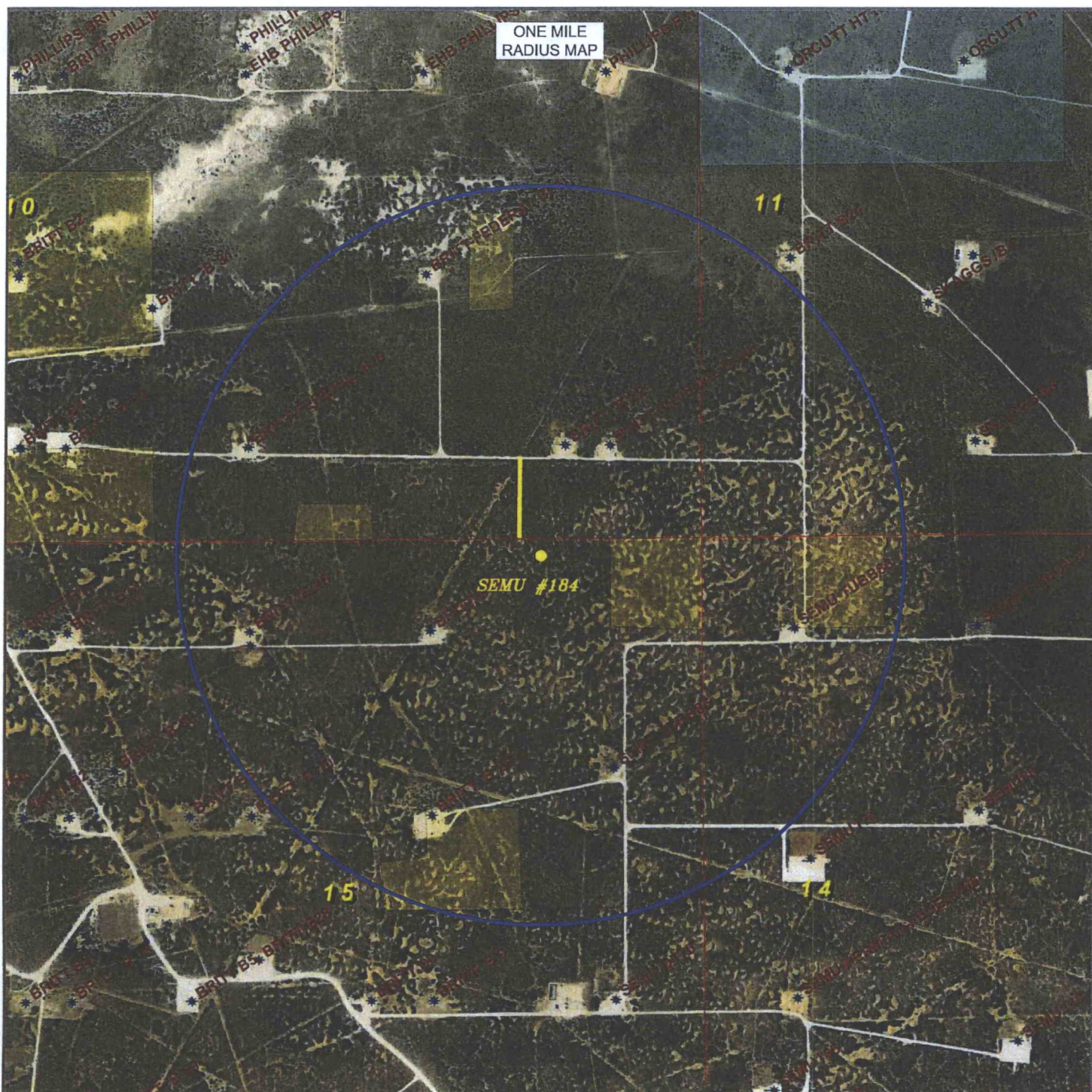
