1st stage: Cement lead w/ 725 sx Life cement, 9.05 ppg, 2.85 CFS yield;

middle w/ 475 sx Class C, 11.0 ppg, 2.75 CFS yield;

tail w/ 303 sx Class H, 15.6 ppg, 1.22 CFS yield.

Circulated 300 bbls cement to surface.

6/3/16 2nd stage: Cement lead w/ 1231 sx 35/65 POZ C cement, 12.7 ppg, 1.86 CFS yield; tail w/ 300 sx Class H, 14.8 ppg, 1.33 CFS yield. Did not circulate.

Notified BLM. Ran temperature log, found TOC at 820'. BLM approved TOC, instructed to proceed with operations. WOC 19 hrs.

Tested casing to 2000 psi for 30 minutes. Test good.

Resumed drilling 8-1/2" hole.
