08-21 thru 27-2016: Drill 8 3/4" hole to total depth of 11,695'. Condition hole for whipstock.  
08-28-2016: PU 500' of 2 7/8" 6.5# tubing, 1st joint orange pealed & 2nd joint slotted, Schlumberger whip stock. RU and run VES Gyro and orient tool to 358 degree gyro and Set whipstock at 10,950'. Drop 3/4 ball wait 30 mins. Set anchor with 2500 psi. Push test with 25k - 3 times. Burst disc with 3800 psi. Drop 1 1/4" ball wait 30 mins. Shear away with 2600 psi. R/U basic cementer's & hold safety meeting. Pump 39 bbls of 17ppg cement Yield-1. Displaced with 188 bbls of 9.5 brine. Pull away from whip stock and circulate bottoms up with 500 GPM.
