8/24/16 - NU BOP. RIH with GR/JB, set down at 1980 ft. Set a 5-1/2 inch CIBP at 1980 ft. Tagged CIBP. Loaded hole with 40 bbls, would not pressure up. Belched out 8-5/8 inch. Spotted 25 sx Class C cement. Started circulating out 8-5/8 inch x 5-1/2 inch at end of displacement. Calc TOC 1733 ft. Worked on 8-5/8 inch head to try and get outlet to seal so can circulate to tank. WOC.

8/25/16 - Tagged cement plug at 1800 ft. Isolated hole in 5-1/2 inch casing above 70 ft.

Perforated 4 holes at 431 ft. Well went on vacuum. RIH with packer to 221 ft and set. Pumped 43 bbls water. Circulated out 8-5/8 inch. Pumped 170 sx Class C cement, circulated. Released packer. Filled 5-1/2 inch casing, topped out.

8/26/16 - Dug out cellar and cut off wellhead. Installed dry hole marker and filled cellar. WELL IS PLUGGED AND ABANDONED.

Approved as to plugging of the well bore. Liability under bond is retained until surface restoration is completed.
