SHERIDAN IS REQUESTING A PLUGGING DATE EXTENSION. UNTIL WE WERE NOTIFIED BY THE BLM, WE HAD NO RECORD OF HAVING ANY INTEREST IN THIS WELL. UPON FURTHER REVIEW, WE FOUND THAT WE WERE SOLD A LEASEHOLD INTEREST ONLY IN SPECIFIC WELLS, THIS BEING ONE OF THEM. HOWEVER, WE HAD NO DATA IN HOUSE OR ELECTRONICALLY. WE HAVE BEEN RESEARCHING AND TRYING TO DETERMINE WELLBORE OWNERSHIP. CANYON E&P IS THE LAST KNOWN OPERATOR OF THE WELLBORE, BUT BECAUSE WE HAVE A LEASEHOLD INTEREST ONLY, WE ARE ON THE HOOK, ALONG WITH PALADIN. WITH THAT BEING SAID, PALADIN IS IN THE MIDST OF BANKRUPTCY, SO THEY WILL NOT BE OF ANY HELP IN THIS MATTER. GIVEN THE CIRCUMSTANCES SURROUNDING THIS WELL AND THE BURDEN THAT SHERIDAN IS HAVING TO INCUR TO PLUG THIS WELL, WE RESPECTFULLY REQUESTS AN EXTENSION TO PLUG THIS WELLBORE UNTIL DECEMBER 15, 2016.
