The effective date of the cancellation was 11/25/2015. Thank you for your phone call yesterday and notifying us that this well was actually spudded and completed and is producing. I have received your C-103 sundry notifying us that this well was spudded on 05/11/2014 and rig was released on 06/10/2014.

I am requesting that Devon expedite the submittal of the following forms:

- 3) C-105 Completion Report
- 4) As Drilled form C-102
- 5) Directional Drill Survey
- 6) Form C-104 request for allowable / authorization to transport

At this time DEVON ENERGY PRODUCTION COMPANY, LP OGRID 6137 does not have a form C-104 "Authorization to Transport" on file and is hereby directed to shut-in the following well 30-025-41517 BELL LAKE 19 STATE #004H [39747] until all missing paperwork is submitted.
