Hunt Cimarron L.P. was granted a six month shut-in status for the Poco Loco Federal No. 1 on February 4, 2016. On February 16, 2016 an Application was filed with the Bureau of Land Management office requesting a right-of-way in order to lay a new flowline to the purchaser's system as they had abandoned the former sales line. Approaching the end of the six month shut-in status the BLM requested an update on two sites of an archaeological survey previously performed along this proposed right-of-way. Hunt Cimarron contracted with an archaeological surveyor to update the sites. This update in the process of being completed.

Hunt Cimarron L.P. requests an extension of six months to complete the archaeological update, obtain the right-of-way and install the flowline to restore gas deliveries and sales.
