ConocoPhillips Company respectfully requests to expand the existing Wilder Pit located in the NENE of Section 28, T26S, R32E, Lea County, NM; as the pit itself currently does not have the capacity to frac COP's nearby wells.

The expansion will shift the east side of the pit approximately 40' to the east on to the existing Wilder 28 Federal 001H well pad (as shown in the attached aerial). This surface is already disturbed, thus, there will be no additional surface disturbance.


This expansion will also be just long enough to not interfere with potential traffic coming onto the well pad.
