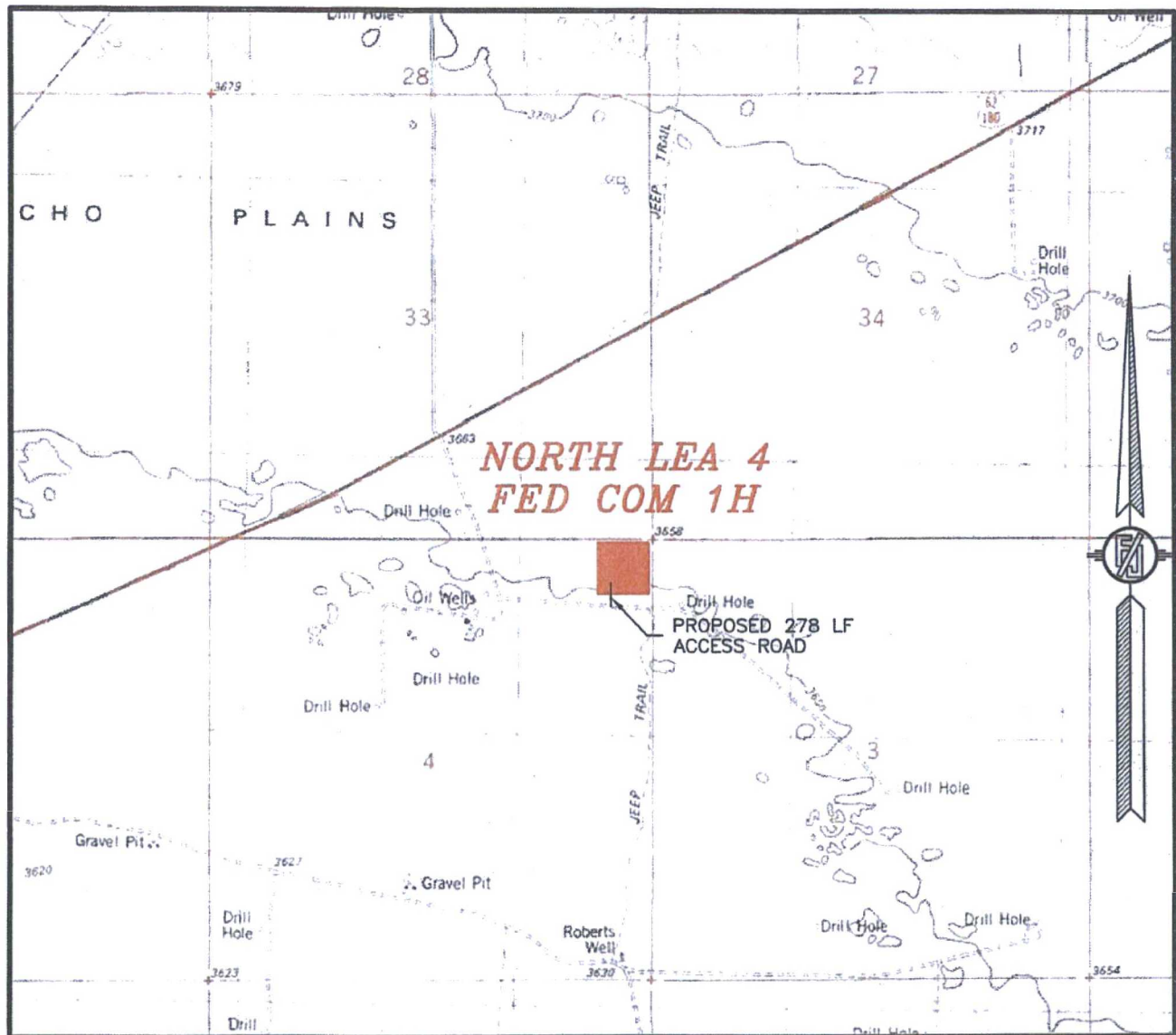

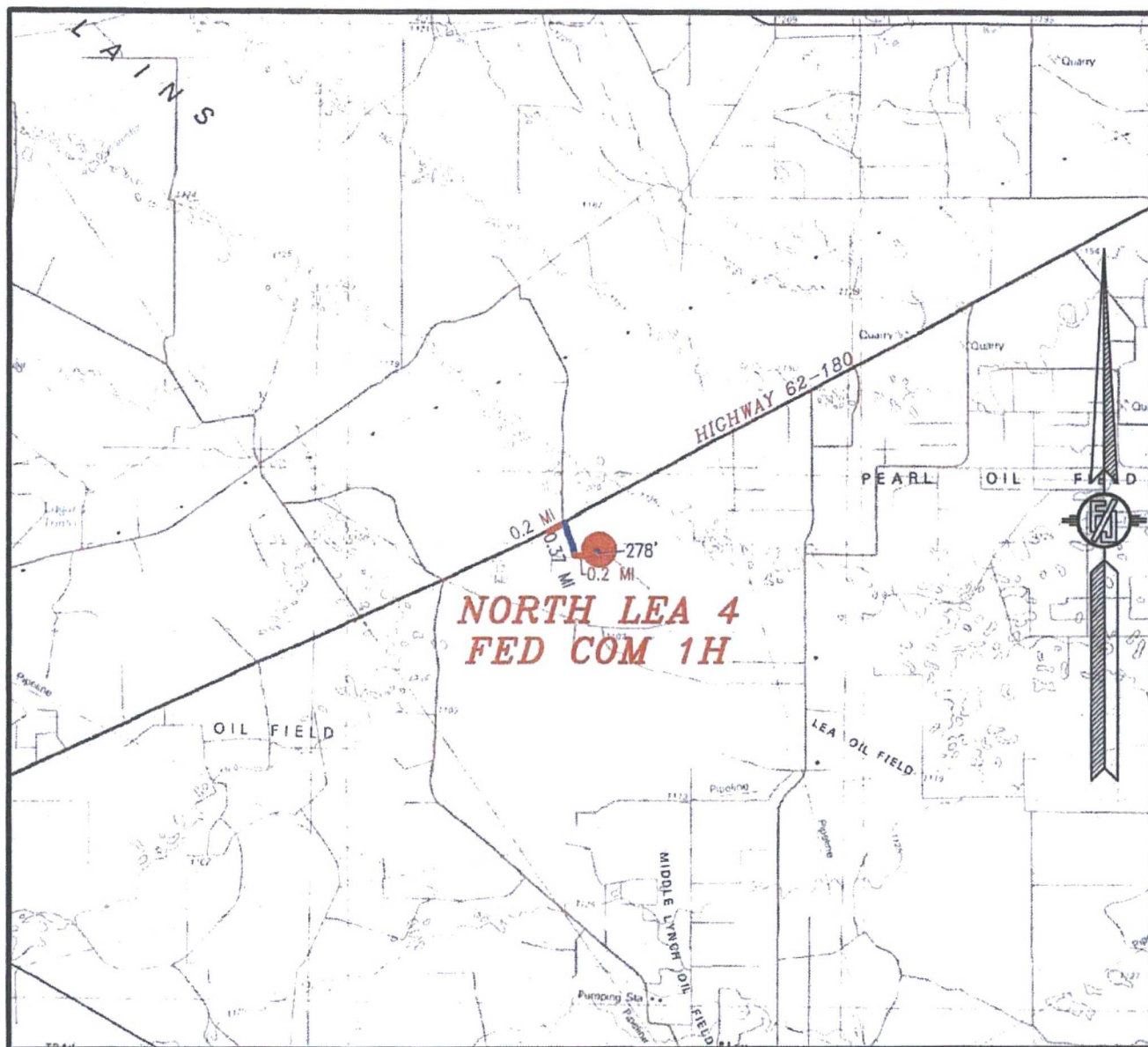

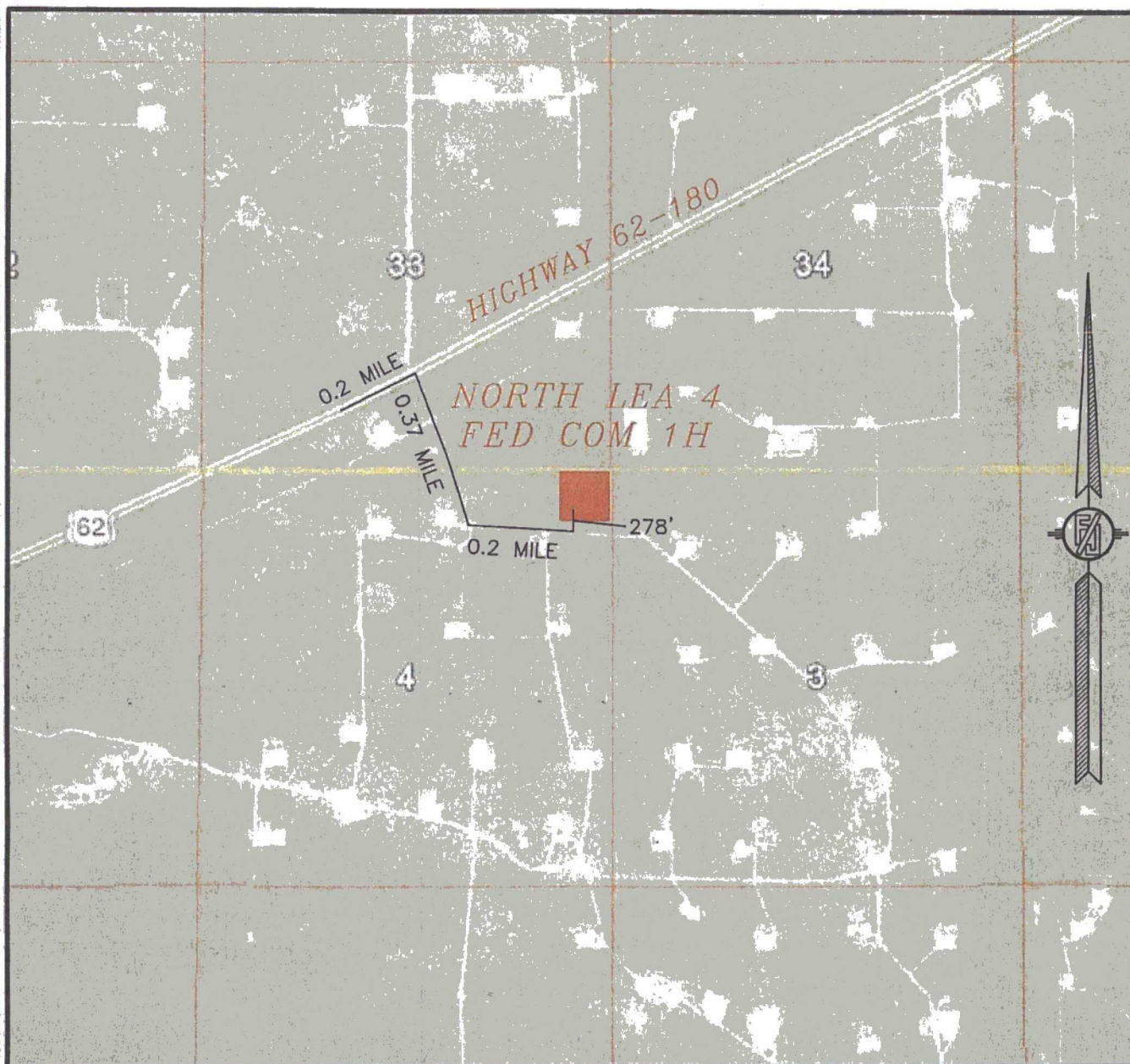

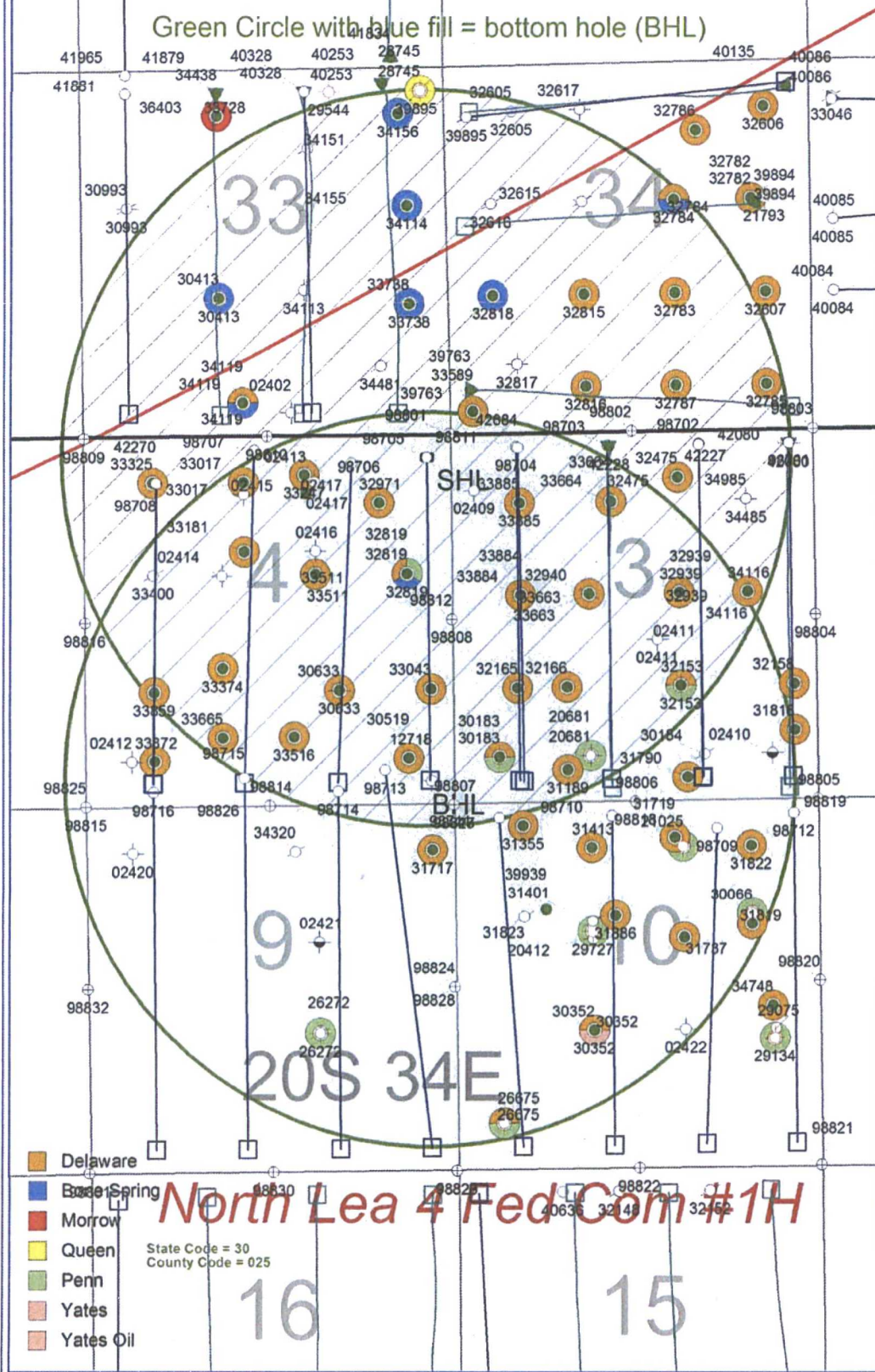

1-MILE RADIUS MAP

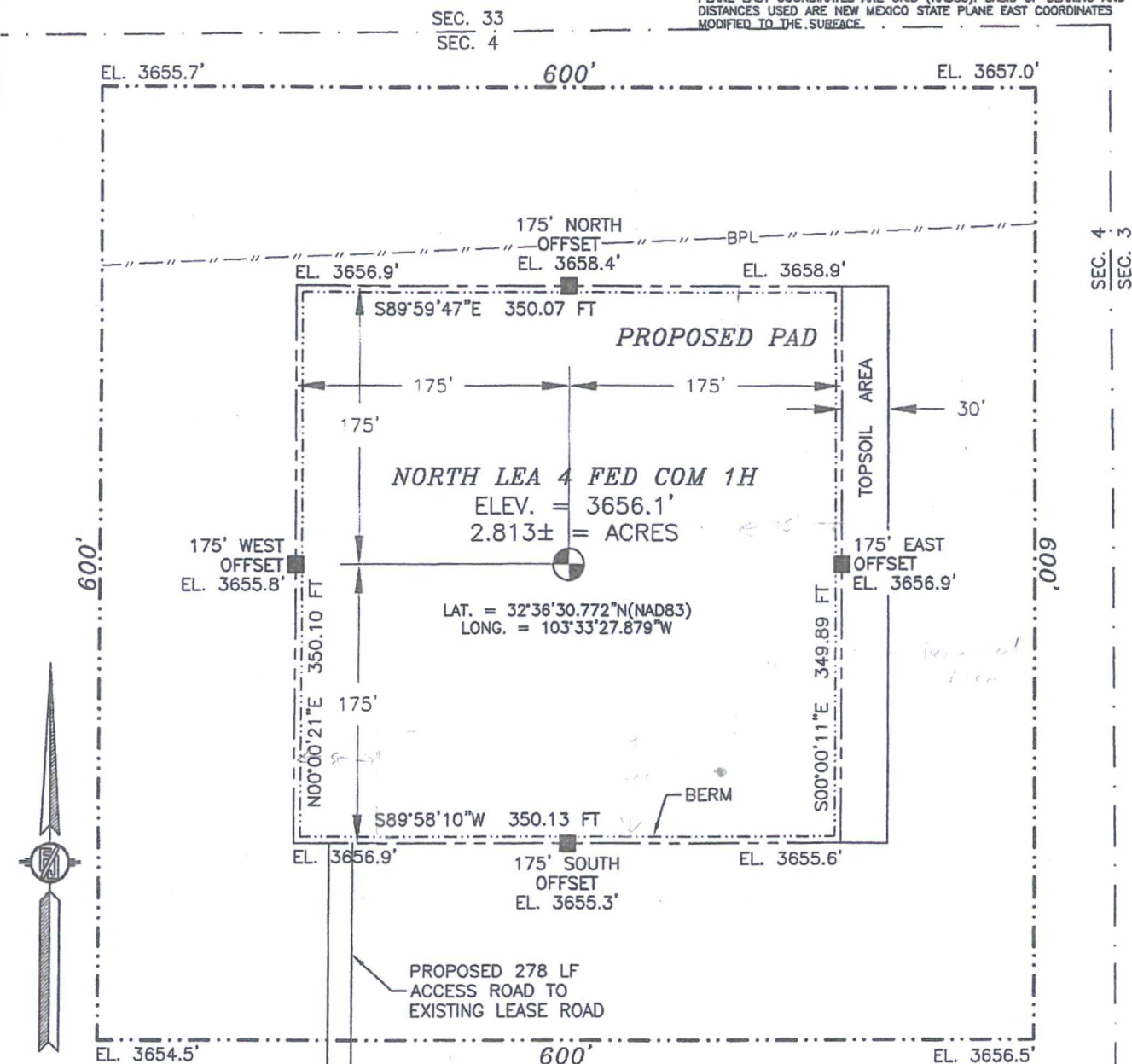
