GMT Exploration flowed back water in the above well in the amount of 1400 bbls of from the 2nd Bone Spring formation after the 2nd stage of fracking. We do not anticipate additional water flowback until after we have completed the well and will provide a more accurate number at that time.

We disposed of the above mentioned water which was held on location in 500bbl frac tanks. We trucked the water using Arapahoe Oilfield Services to the OWL Madera site. Please see below for our primary and secondary disposal sites for the above well.
