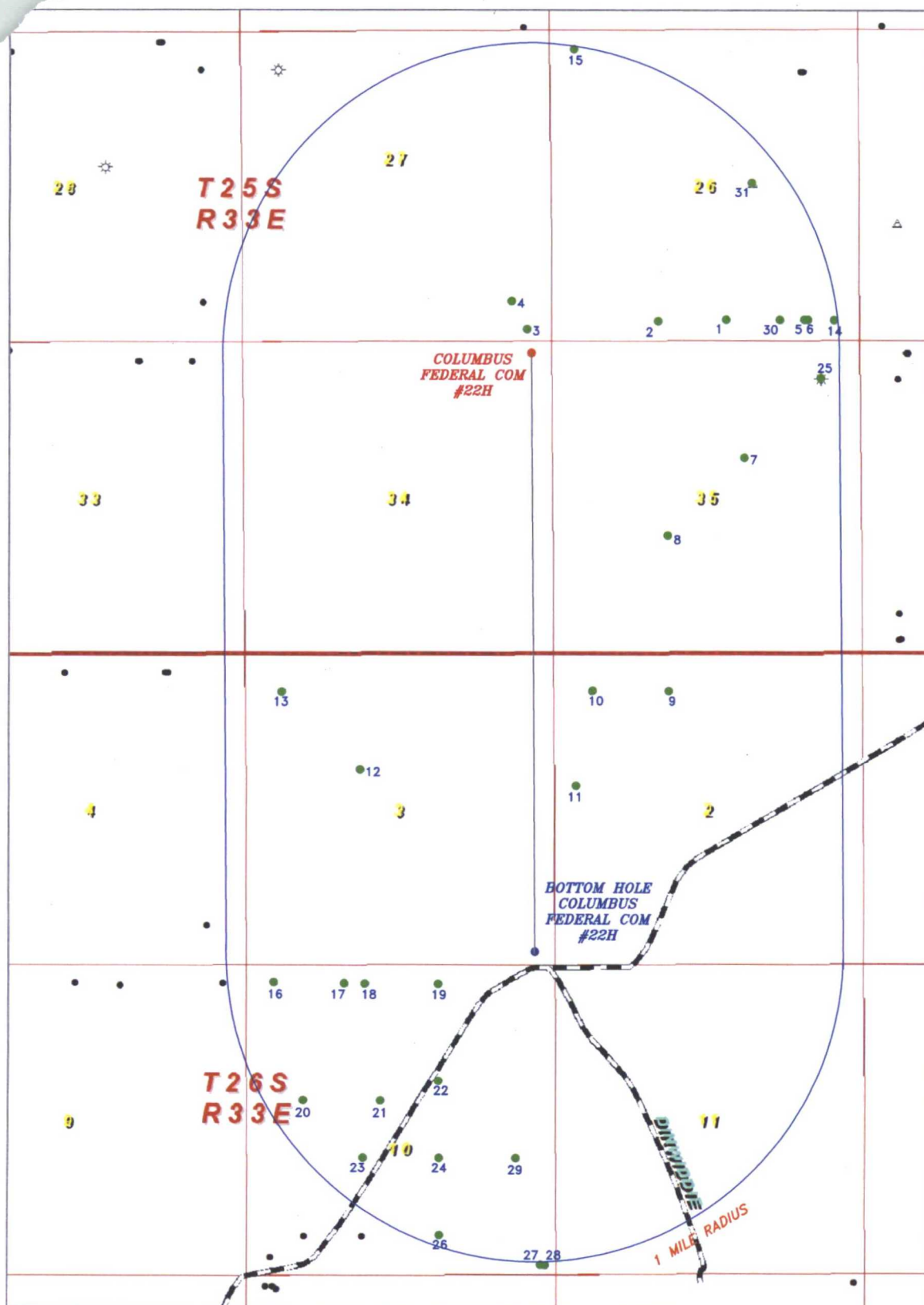
COLUMBUS FEDERAL COM #21H AND BOTTOM HOLE LOCATION

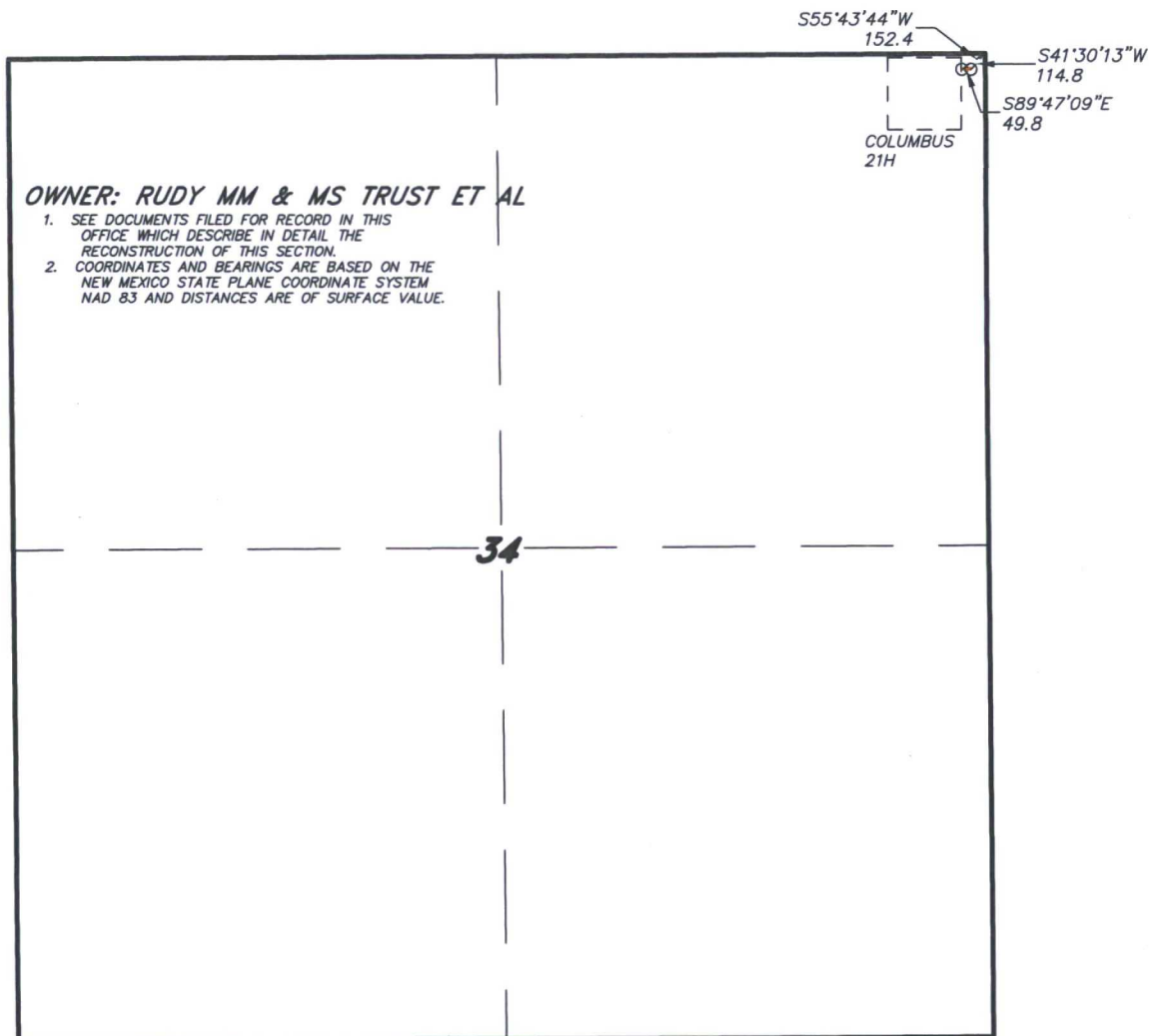

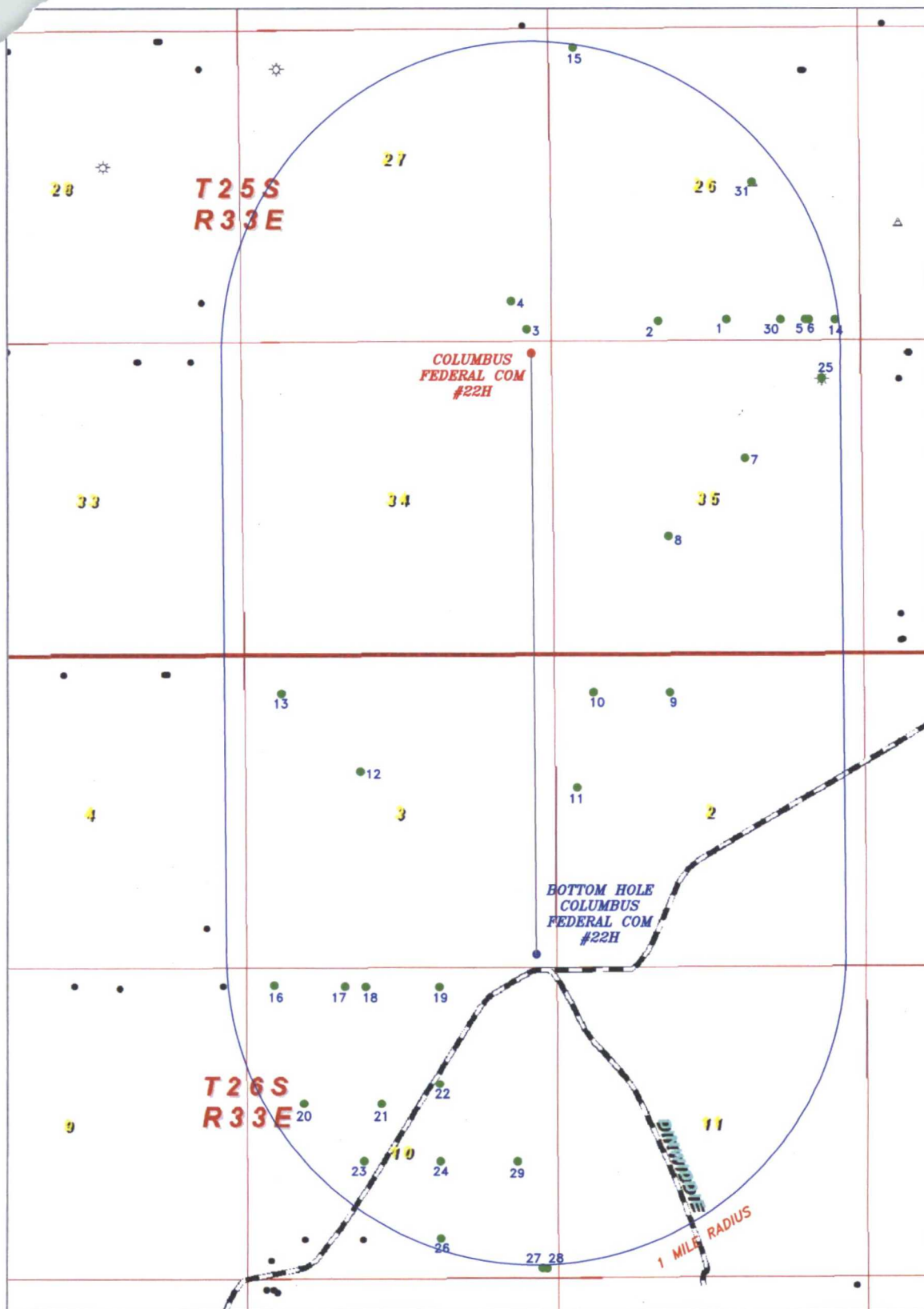
