3/15/17: RU WLU and RIH with CBL tool, tag TOC @ 4,915' and perform CBL to surface. No cement surface - 500'. Circulate hole with salt gel mud, mix and spot 25 sxs class "C" cement from 4,939'-4,891', witnessed by BLM Paul Flowers, WOC

3/16/17: TIH and tag TOC @ 4,677', test casing to 700 psi - good, notify BLM, mix and spot 30 sxs of class "C" cement from 4,051'-3,754' (DV Tool) Mix and spot 30 sxs of class "C" cement from 3,082'-2,786' (Queen), mix and spot 30 sxs of class "C" cement from 2,303'-2,007' (Yates). RU WLU and perf @ 1,100'. EIR of 2 bbl/min @ 800 psi with good circulation out 8-5/8 casing. Mix and pump 400 sxs of class "C" cement down 5-1/2" casing and circulated to surface. RDMO.

Will send in surface crew to cut-off wellhead, install marker and restore location

Closed loop system used for all fluids.
