- 4/6/2017 Cleared location, worked on road and spotted rig.
- 4/7/2017 Rigged up. Installed wellhead on 5 ½" casing and installed BOP. Well was standing full of fluid. Hooked up vac truck to the casing. RIH with workstring and tagged existing CIBP at 3278'. Moved remaining equipment to location and shut down.
- 4/10/2017 Circulated MLF and tested casing to 500#. Held Good. Spotted 25 sx Class C cement on top of CIBP. POOH to 2502' and spotted 25 sx cement. POOH to 1170' and spotted 25 sx cement. POOH to 586' and circulated cement to surface with 60 sx. Rigged down and worked to get unit off location.
- 4/11/2017 Dug out and cut off wellhead. Filled up both strings with 35 sx cement. Installed marker and cleared location.
