ConocoPhillips Company respectfully requests approval to change plans for this well.

Our updated surface use plan includes the following adjustments which will not result in additional surface disturbance:


- Either polyline or fiberspar will be used as surface flowlines.
- Temporary production test equipment may be used at the well location or the Ruby S18 CTB.
- Temporary tanks for completion operations may be staged on adjacent well pad.
- An additional water source may be used; Rockhouse Ranch, 1108 W. Carlsbad, NM 88220.

The rig to be used requires moving the "stinger" (20'x 40' section) to a different side and a slightly larger pad. The additional surface disturbance is 10'x260' equal to 0.06 acres and will be reclaimed following initial operations.
