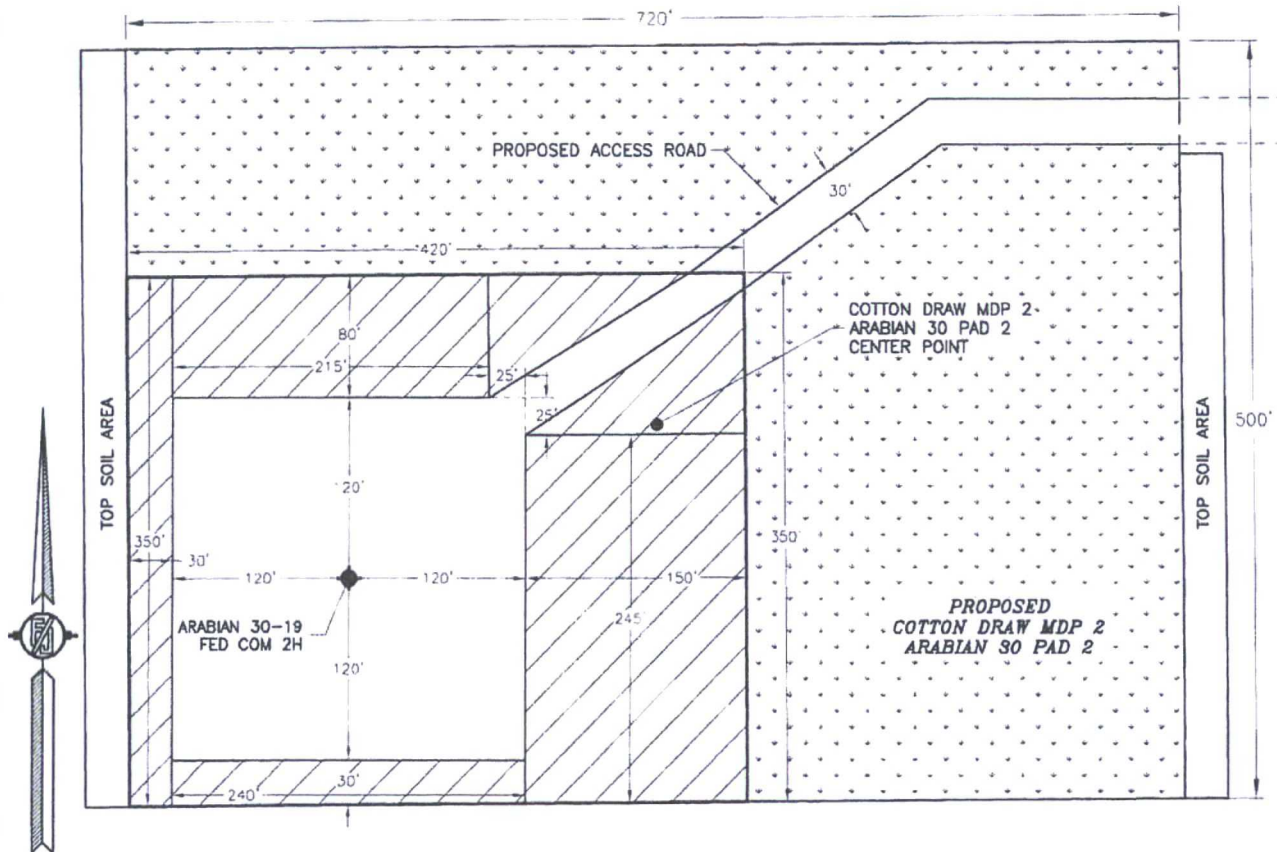

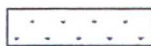
**PROPOSED INTERIM SITE BUILD PLAN

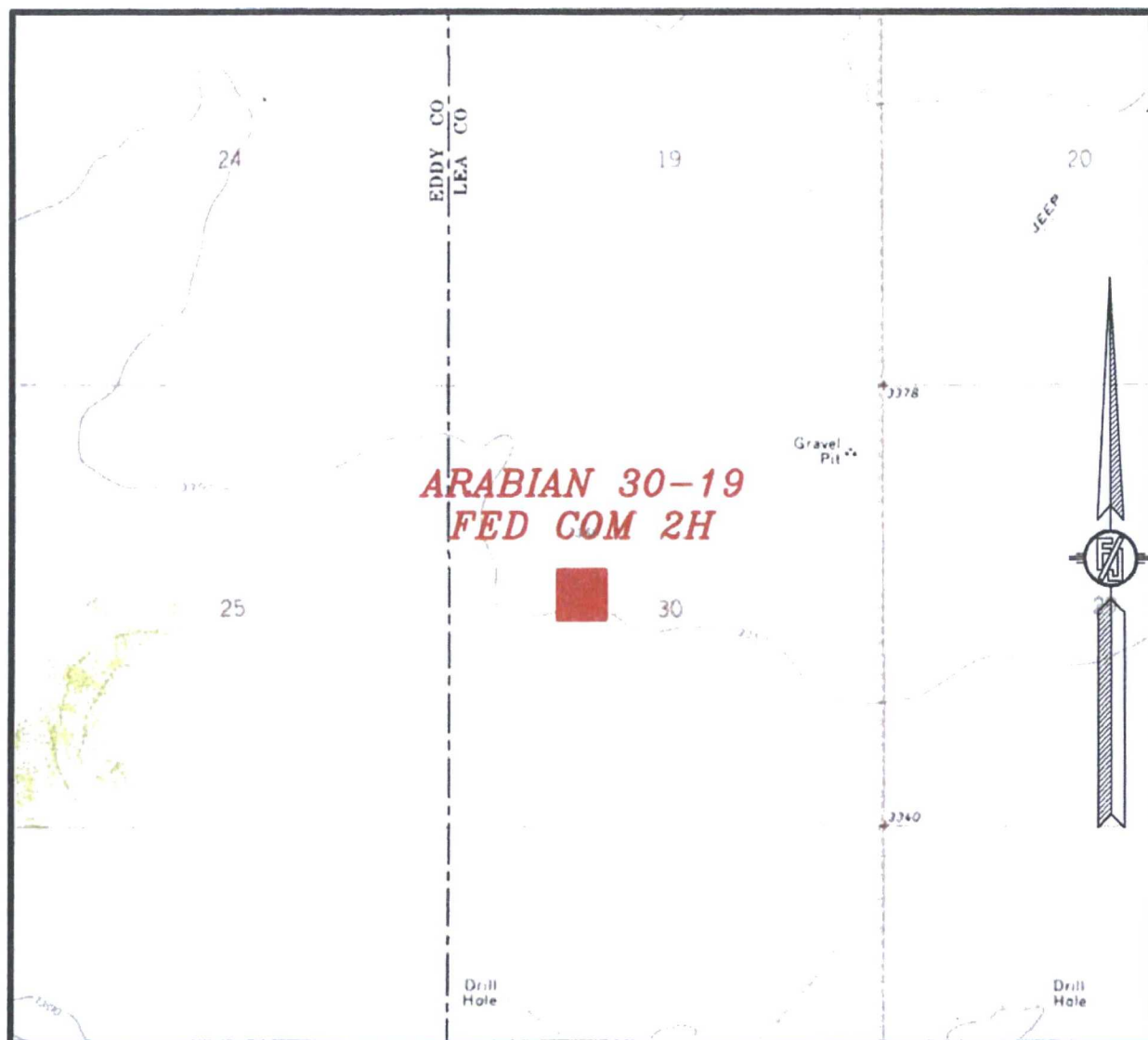

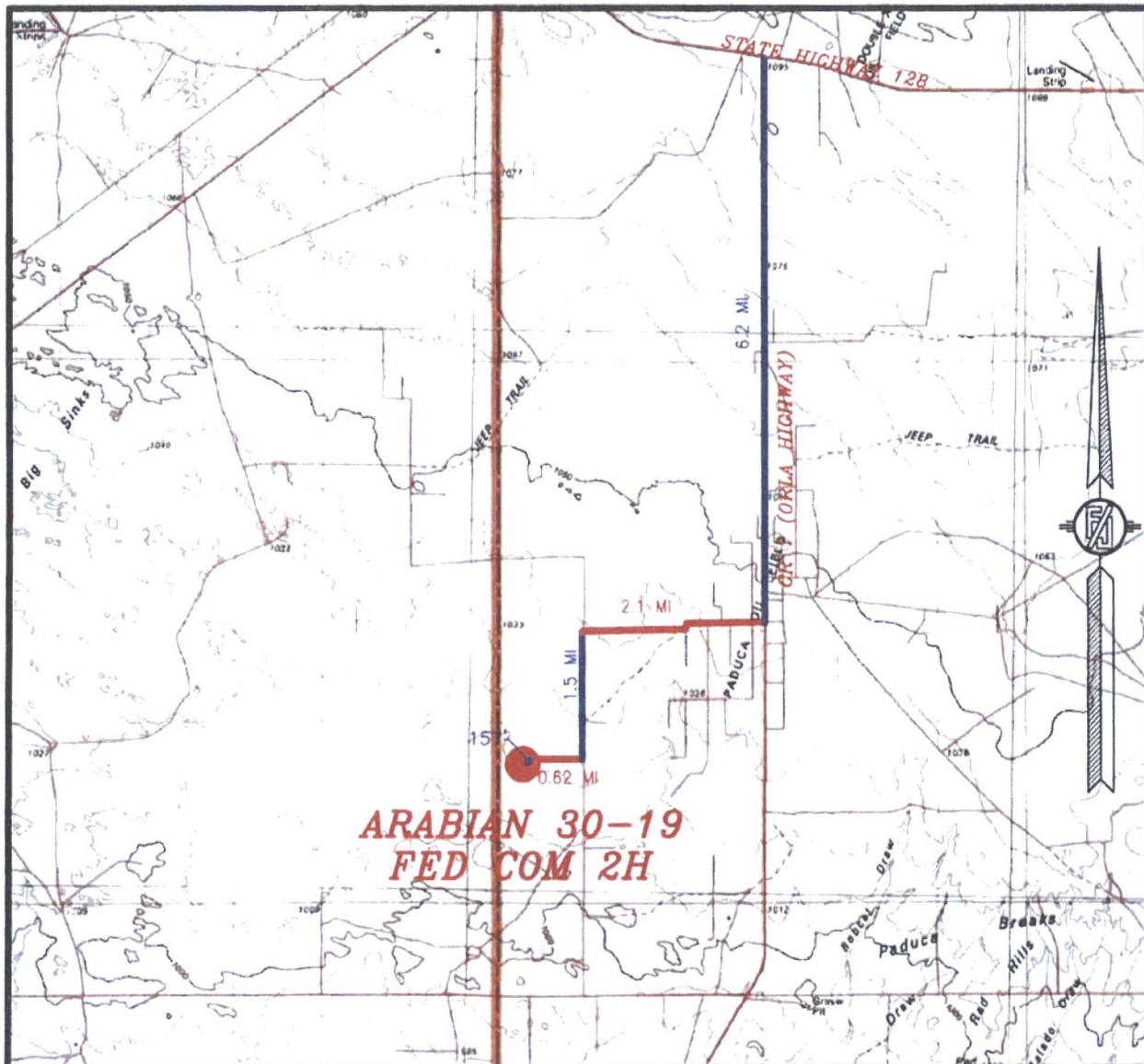

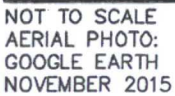

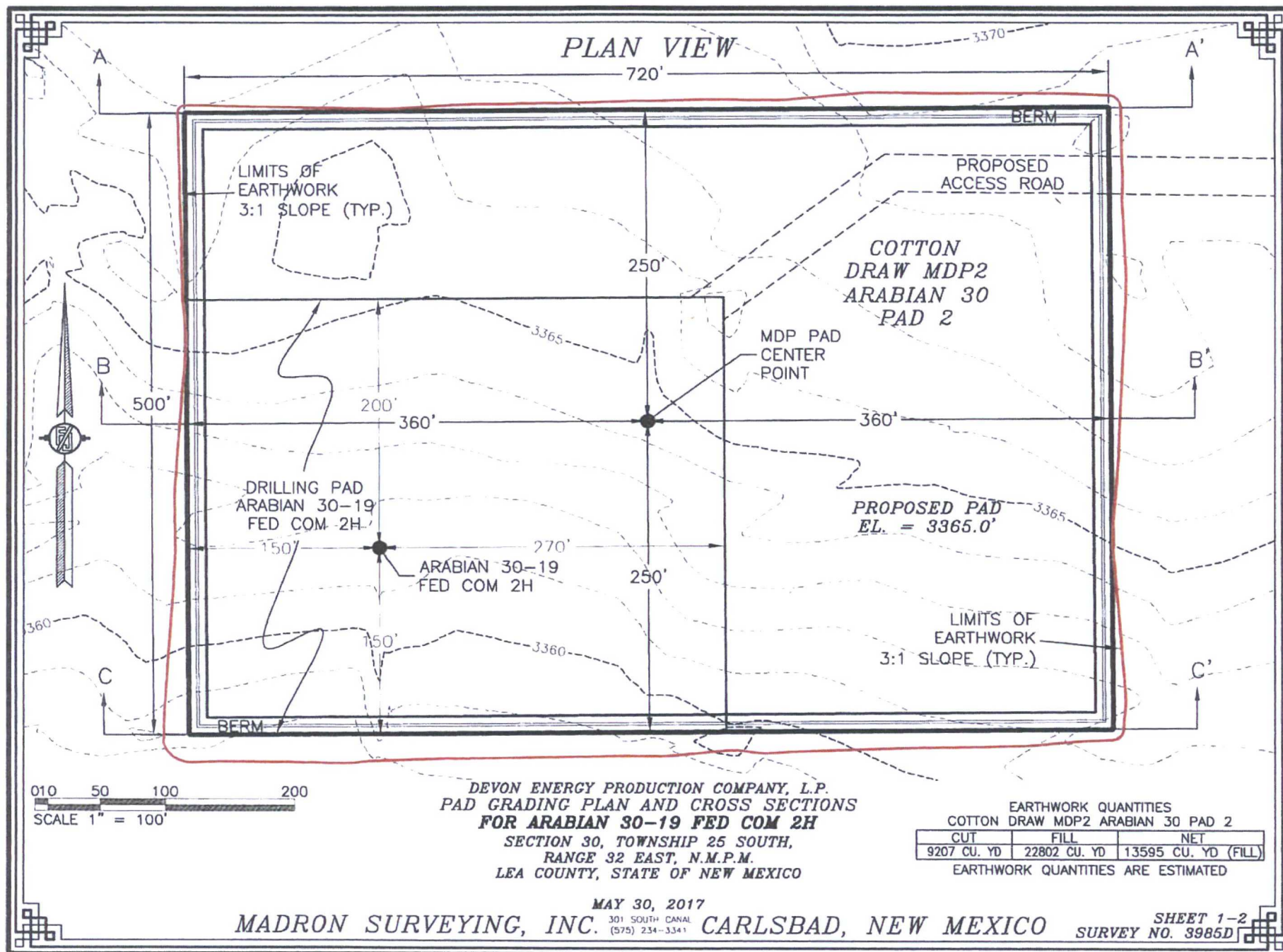
ACCESS AERIAL ROUTE MAP

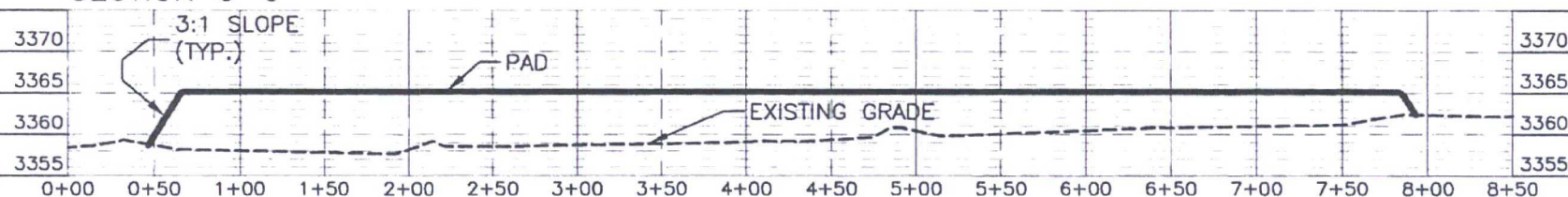
