7/10 - 7/11/2017: MIRU PU, SION

7/11 - 7/12/2017: Bleed well down, unseat pump, POOH & LD rods and pump. NDWH, NUBOP, unset TAC and POOH w/ 2 7/8" tbg, Close well in and SION.

7/12/2017-7/13/2017: RIH w/tbg and CIBP, set at 3800'. Test CIBP & casing, will not test, got injection rate of 2 BPM @200#. Notified NMOCD, advised to set 40 sx cement plug on CIBP. Mix and spot 40 sx "C" from 3800' to 3400', pull up and WOC 4 hrs, RIH and tag cement at 3445', notified NMOCD. POOH and RIH w/pkr and tbg to 1935', set pkr, test csg below pkr, no good, 1/2 BPM @ 500#, test above pkr, no good, 2.5 BPM @100#, POOH w/pkr, crew had AD-1 packer in upside down. Close Well in, SION.

7/13 - 7/14/2017: RIH with new pkr to 1935', test cement plug and casing to 700 psi for 15 minutes. Good test. Hunt csg leak, bottom of leak @ 1393' has circulation to surface. Notified NMOCD, advised to perforate @ 1935'. Perf @ 1935', could not pump into perfs, spot 50 sx cement plug @ 1992', POOH w/tbg, SDON, WOC.

7/14 - 7/15/2017: Tag cement plug @ 1830', isolate leak interval per NMOCD. Top of leak @ 601', bottom @ 1392'. Spot 95 sx cement plug @ 1450', WOC, Tag @ 696', spot 30 sx cement plug @ 690', perf @ 270' and 69', WOC. SDON

7/15/2017: Tag cement @388', squeeze shot hole at 270' with 80 sx cement, displace to 170' WOC, tag @ 165, circulate cement to shot hole at 60', had good returns out 13 3/8" casing as well. ND BOP. SION

7/16/2017: Cut off well head, RDMO. P&A complete.
