5/24/17 1st stage: Cement lead w/ 1110 sx LUCEM, 10.8 ppg, 2.44 CFS yield; tail w/ 315 sx Class H, 15.6 ppg, 1.22 CFS yield. Did not circulate. TOC at 6200' CBL.
2nd stage: Cement lead w/ 1550 sx Class C, 12.7 ppg, 2.37 CFS yield; tail w/ 200 sx Class C, 15.6 ppg, 1.37 CFS yield. WOC 4 hrs. Circulated 308 sx cement to surface. WOC 9 hrs.
5/25/17 Tested casing to 2000 psi for 30 minutes. Test good. Resumed drilling 6-3/4" hole.
