2nd stage: Cement lead w/ 1250 sx Lucem, 10.8 ppg, 3.03 CFS yield; tail w/ 51 sx Class C, 14.8 ppg, 1.45 CFS yield.  
Circulated 270 bbls cement to surface. WOC 8 hrs.

6/16/17 Tested casing to 2600 psi for 30 minutes. Test good.  
Resumed drilling 6-3/4" hole.
