Frontier would not let us into their line due due to the nitrogen content being too high for them to process. We flared 110 mcfpd. We had a 90 day flare permit but it expired 5/6/17. We ended up having to continue to flare 5/7/17 through 5/10/17 until we were able to commingle the gas production into a different battery. So Fasken is asking for a flare permit for those 4 additional days.
