Re: 30 day Notice of Termination of New Mexico Salt Water Disposal Easement Number SW-93-2 (Lea 20 State SWD #1)

Dear Mr. Chance,

Enclosed is a copy of a letter our office sent to you on March 7th, 2017 notifying you of the upcoming expiration date of July 13, 2017. To this day, we have not received the necessary information to consider a renewal. In our geotechnical review has revealed that your injection may prove detrimental to the Capitan Aquifer. Such injection has been opposed by the NMSLO and that practice will continue. Consequently your renewal application will be denied.

Because your easement will not be re-issued you must cease all disposal operations. You have 30 days from the date of this letter to contact the Land Office with your plans for plugging and abandoning the well. Please be advised that after July 13th, 2017 this well is operating in trespass, and this issue may be forwarded to our legal division for possible further action.

RE: Expiration of SW-93, Chance Properties

- This easement expired on 7/13/2017
- No renewal application has been received by SLO as of 7/27/2017.
- API 30-25-25957, in the SE4SE4 of section 20, 26S-36E, was converted to an SWD in 1978 under order SWD-210-0, and is still listed as active and the last injection reporting was for April 2017.
- Total depth of the well is 3420 feet deep.
- The well is injecting produced water from multiple hydrocarbon producing zones, including the Devonian, Queen, 7-Rivers and Langlie Mattix into the Capitan Reef aquifer per the OCD order, which contains water of a quality that is protectable in the State of New Mexico.
- The injection zone is between 3325-3420 ft, through an open hole.
- Unless a new injection zone outside of the Capitan Reef aquifer is pursued, via a new C-108 through the OCD, we do not recommend renewal of this easement, as the Capitan Reef aquifer is protectable in the State of New Mexico.

Recommendations:

- Contact operator to inform them that their easement has expired effective 7/13/2017, and all activity of injection must cease immediately.
- The DRM should inspect the location, which had trash and leaks last year when it was inspected, to make sure that the operator complies with the cease & desist letter.
- Clean-up should be required at the site before the bond is released to the company.
