

Existing 5 3/4" over shot w/ 2 7/8" grapple, 2' x-over sub on 30' of 5 3/4" wash pipe, 5 3/4" top bushing w/ cut right 2 3/8" ID, with 4 5/8" x 2 7/8" x-over w/ 2 ½" ID. 36.6" long). Tagged the top of the fish @ 3007'. Picked up with no tension. TOH w/1 piece of 2 7/8" tbg 27' long. Had to cut the fished tbg in 3 section to remove from the fishing tools. No metal, no cement and no formation. Eventually losing circulation. TOH w/ (BHA #3). Assemble, picked up and TIH with (BHA#2). Tagged top of fish @ 3034'. Washed over top of fish'.
