Devon Production Co., L.P. drilled the conductors for the Rebel 20 Fed 6H & 2H. While drilling the mouse hole on the 6H, we collided with our conductor 70' below ground level so we are going to need to drill a new conductor and mouse hole for the 6H. Cactus 167 will be drilling this pad and the equipment out there breaks down in 10' intervals, so it would be easier to move the well 10' (40' or 60' spacing for the 2 wells.

Devon respectfully requests to change the Surface Hole location from 250' FNL & 1980' FWL to 250' FNL 1970' FWL.
