Well had stopped taking water for disposal. Based on plugging history (due to scale) of the well, it was decided to pull tubing. RU JWS. NUBOP. Unset pkr, TOH w/ thg (3 1/2" x 5 ft y 2 3/8" PC). Used Envirovat= due to plugged thg. TIH w/ R & R 4" PC pkr and Rabbitted all tubing in the hole. Replaced one jt of 2 3/8" and one jt of 3 1/2". Circulated pkr fluid. Set pkr @ 11443'. Tested tubing casing annulus to 450' for 35 min. All good. George NMOCB was notified 24 hrs. ahead by J. Reynolds. George confirmed the test. Returned well to SWD after 1000 gal. 15% acid. RD 12.18.17
