Devon Energy respectfully requests to plug and abandon the Seawolf 1-12 Fed 94H, due to conductor parting at 80' and filling up with sugar sands.

Per previously obtained verbal approval, Devon intends to proceed with the following:

? Plug hole with neat class C cement.

? Utilize 2" tubing to run into the hole to where conductor has parted and filled the hole with sand at 80'.

? Begin cementing operations to plug up the open hole and return cement back to surface.

? Excess cement volumes will be pumped in order to fill any void spaces in the open hole beneath the parted casing.

Devon intends to skid the rig 10' and will request the name of this location to be Seawolf 1-12 Fed
