

If the operation results in a multiple completion or recomple in a new interval, a Form 3160-4 must be filed once testing has been completed. Ridgeway Arizona Oil Corp (Ridgeway) requests approval of the Final Abandonment for the Federal 24 #1. All equipment, debris, and power poles have been removed and the site has been properly re-contoured and returned to its original surface.

Ridgeway also requests approval to remove the Federal 24 #1 well from the bond requirement.
