12/15/17: MIRU PU. Unflange wellhead and nipple up BOP. Begin tallying tubing out of well. SD.

12/16/17: Finish tallying out with the tubing. Rig up cement pump. SD waiting on wireline truck.

12/21/17: Attempt to set CIBP at 8700'. Wireline truck break down. SD.

12/22/17: Plug #1: Set CIBP at 8700'. Dump 35' class "H" cement on CIBP. SD.

12/26/17: Tag plug #1 with tubing at 8673'. Pump 80 bbls. of 10.5# plug mud. SD.

12/28/17: Plug #2: Set CIBP at 5850'. Circulate 90 bbls. of 10.5# plug mud. SD.

01/05/18: Load well with 10 bbls. of 10.5# plug mud. Pump 25 sx 14.8# class "C" cement from 5850' to 5602'. Displaced with 32 bbls. 10.5# plug mud. Pull up to 3435. Load hole with 15 bbls. 10.5# plug mud.

Plug #3: pump 35 sx 14.8# class "C" from 3435' to 3075'. Displaced with 17 bbls. 10.5# plug mud. SD.

01/08/18: Tag plug #3 at 3199'. RU wireline and perforate at 675' load well and circulate 15 bbls. of 10.5# plug mud.

Plug #4: Squeeze and pump 200 sx 14.8# class "C" cement. RDPU and SD.

01/09/18: Cut off wellhead and weld dry hole marker plate. Dig out and cut off anchors. Plugging completed.
