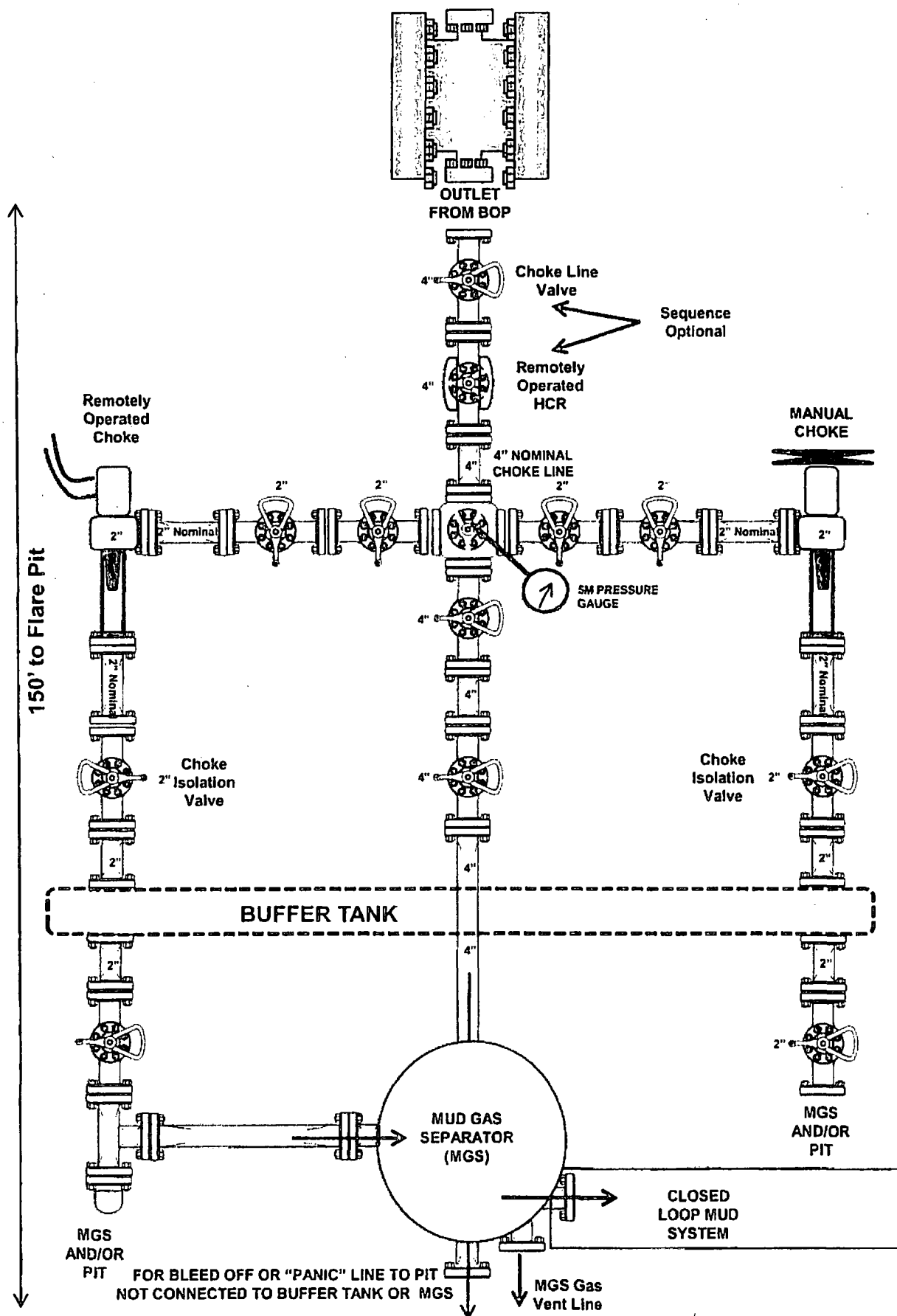

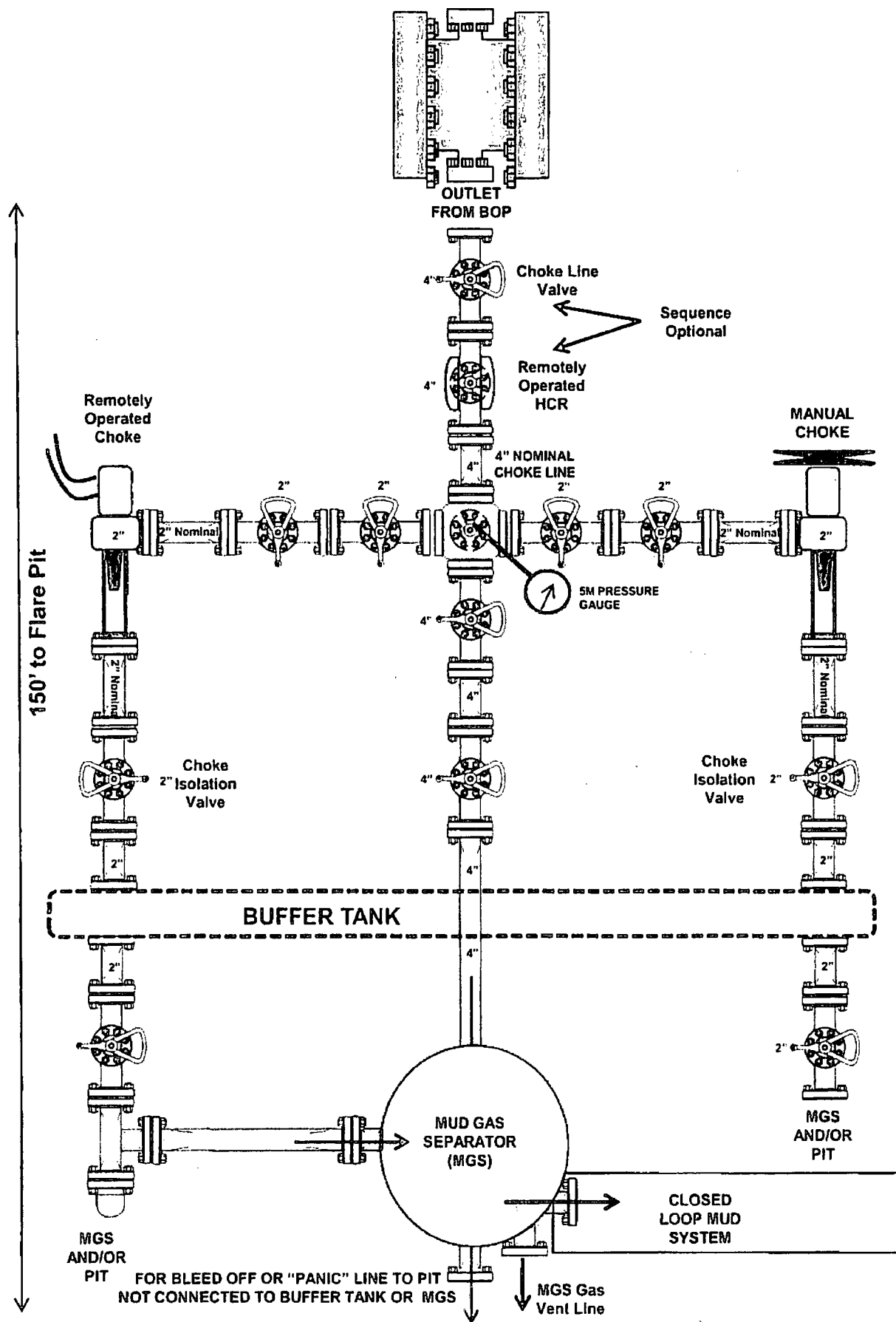

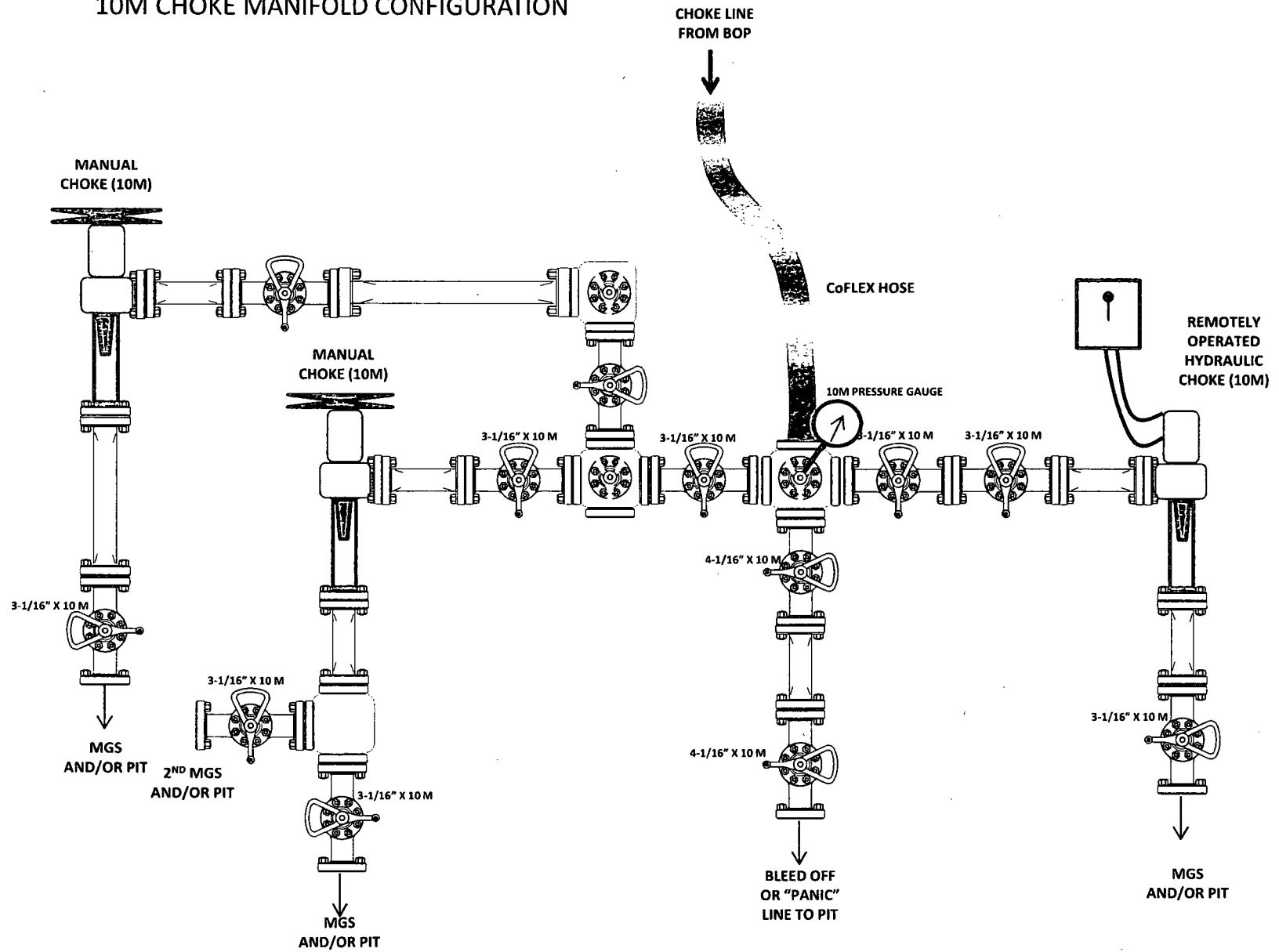
# 3M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



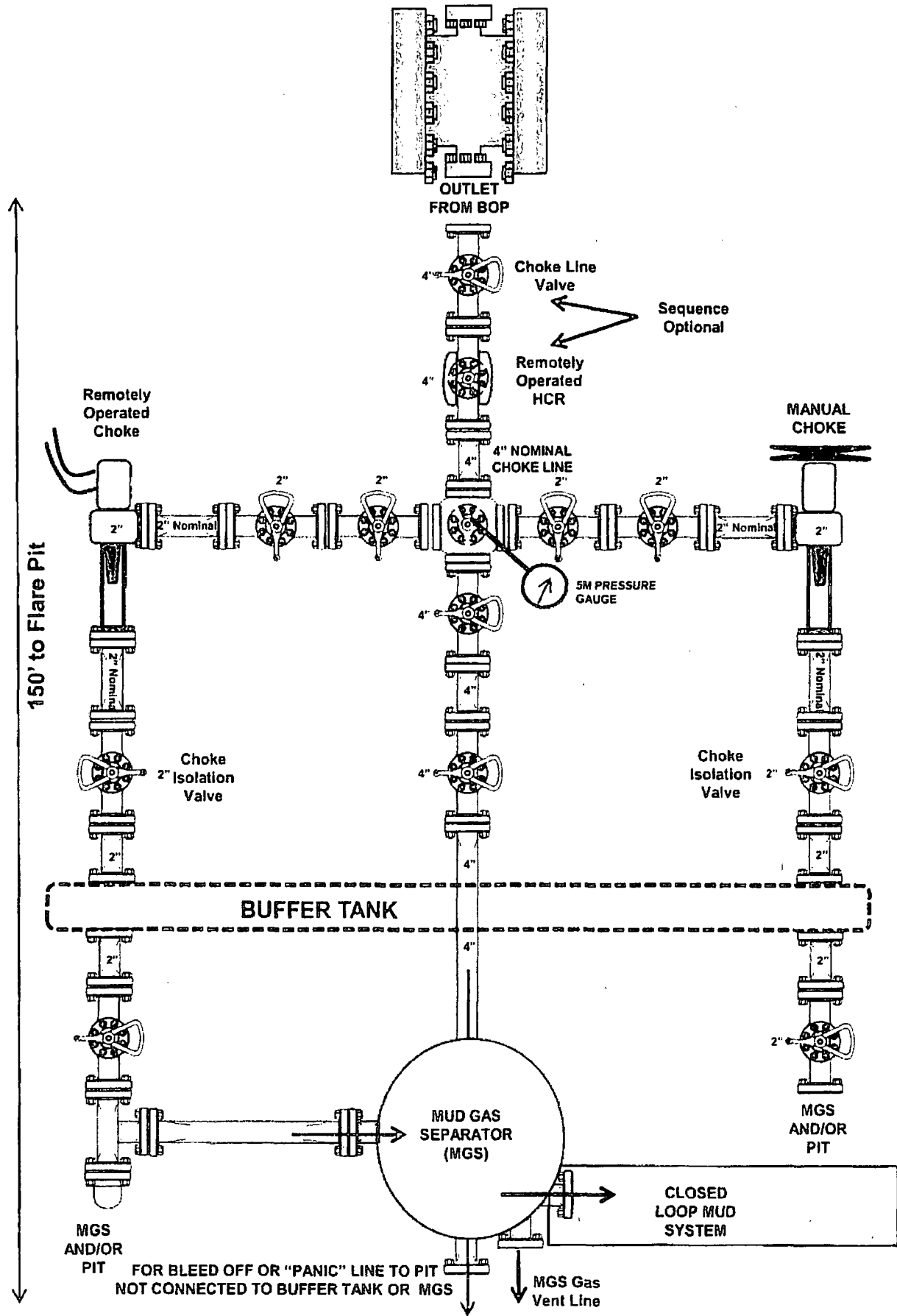
# 5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



## 10M CHOKE MANIFOLD CONFIGURATION

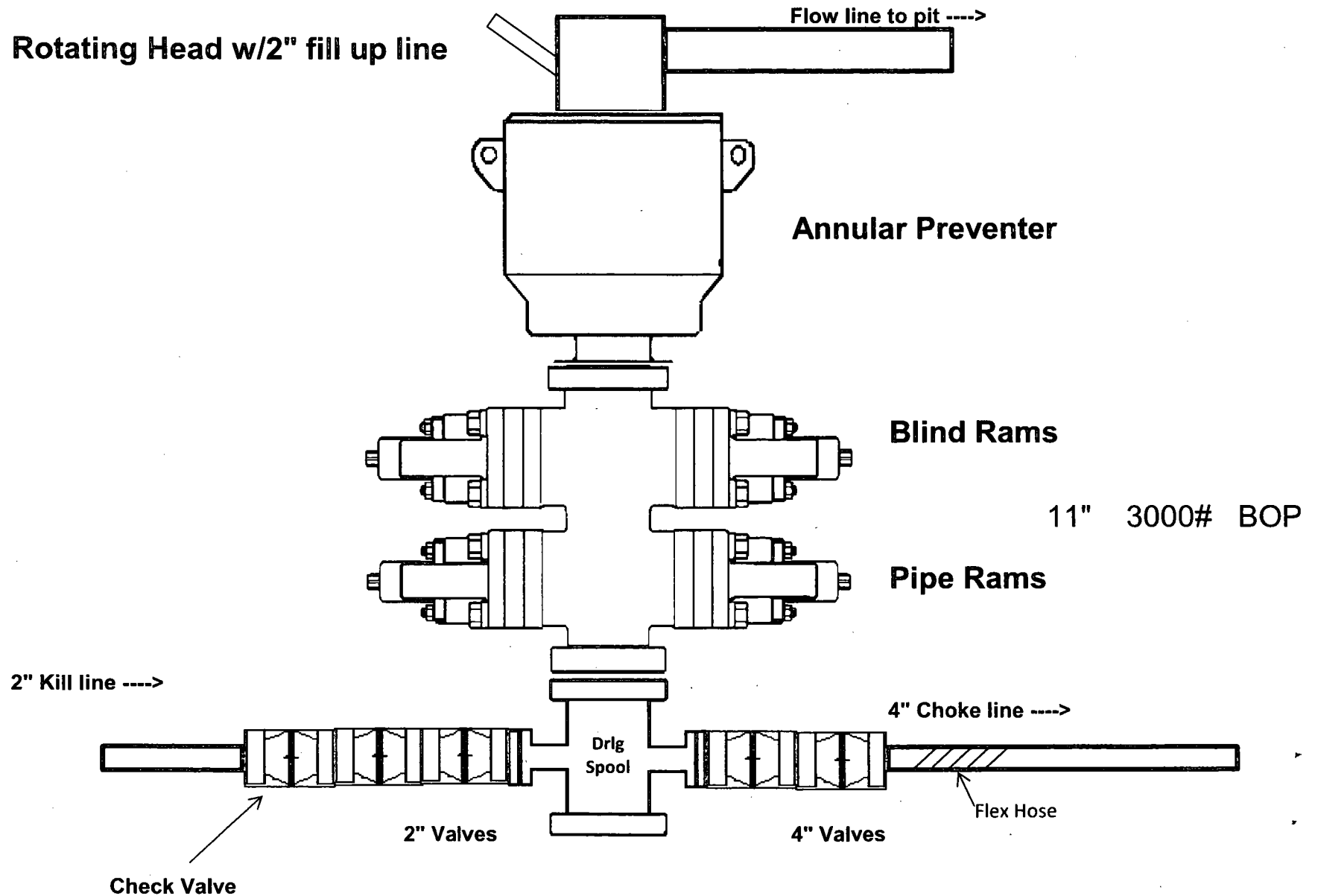


# 5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)

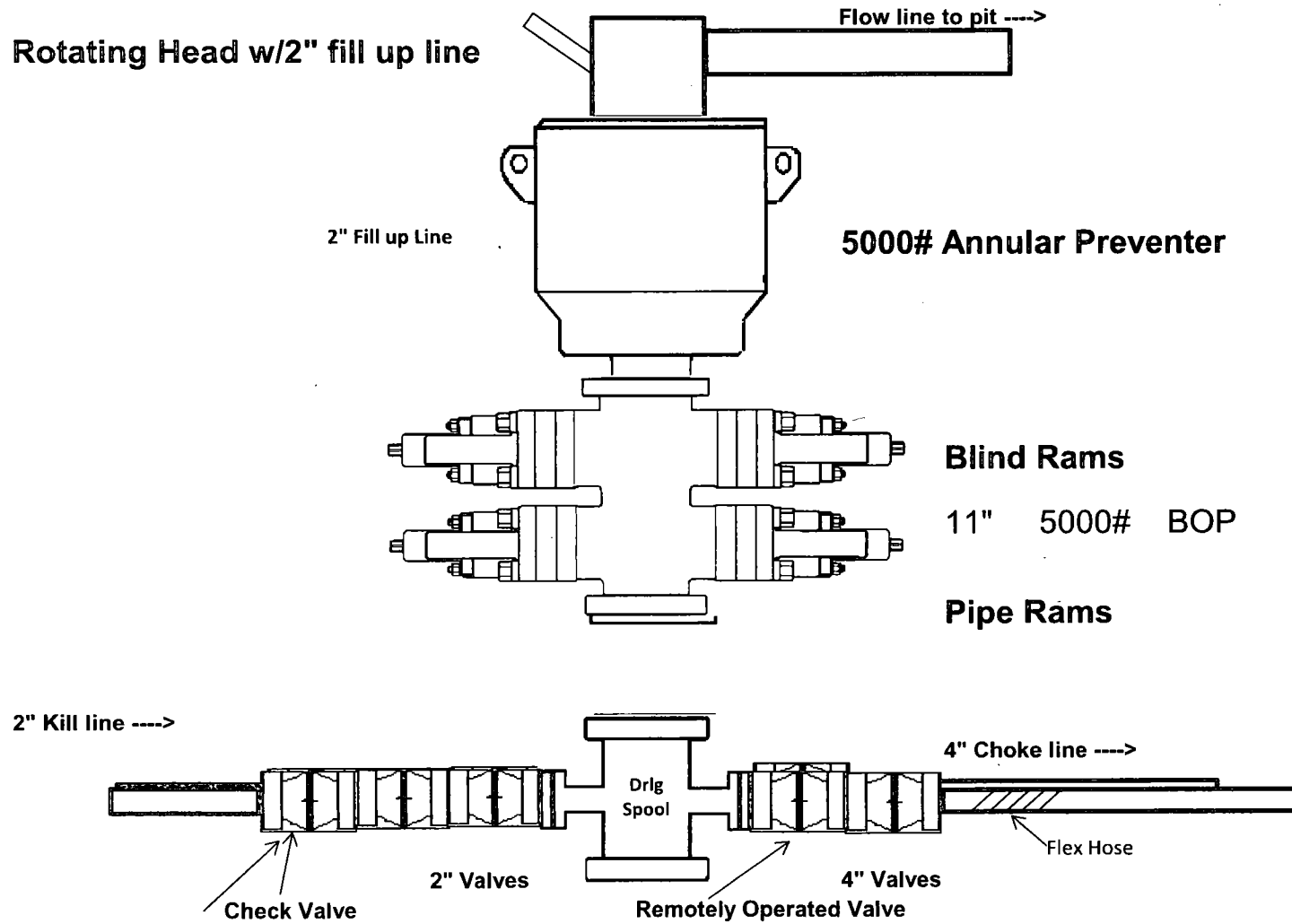




# 3,000 psi BOP Schematic

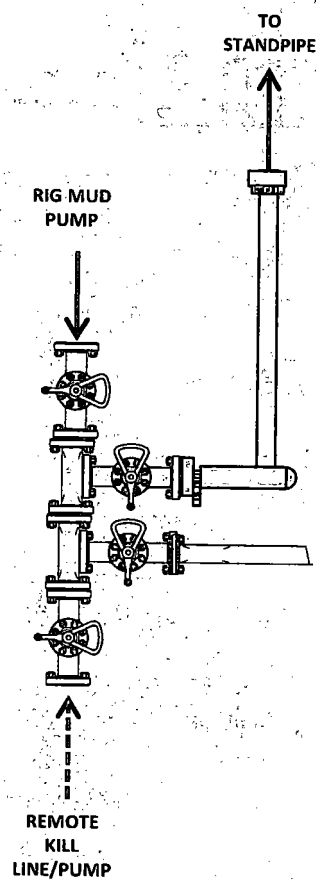


# 5,000 psi BOP Schematic

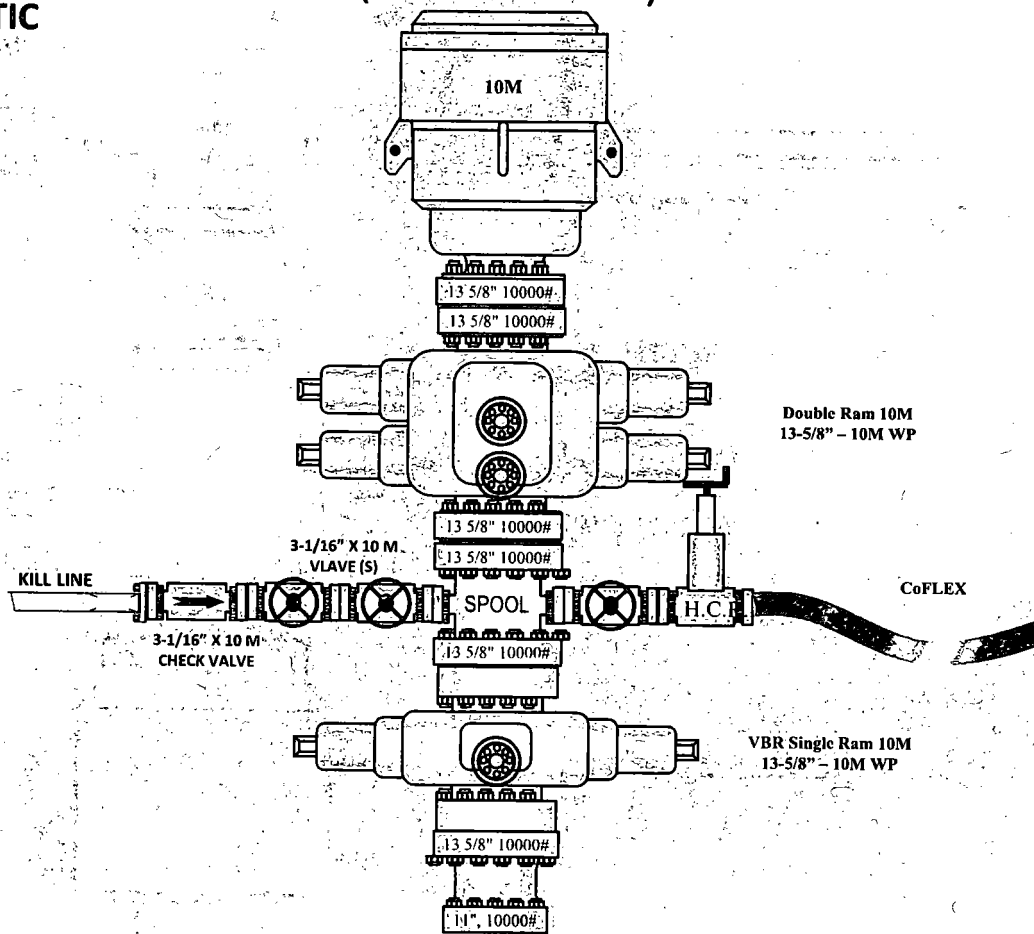


# 10M BOP Stack

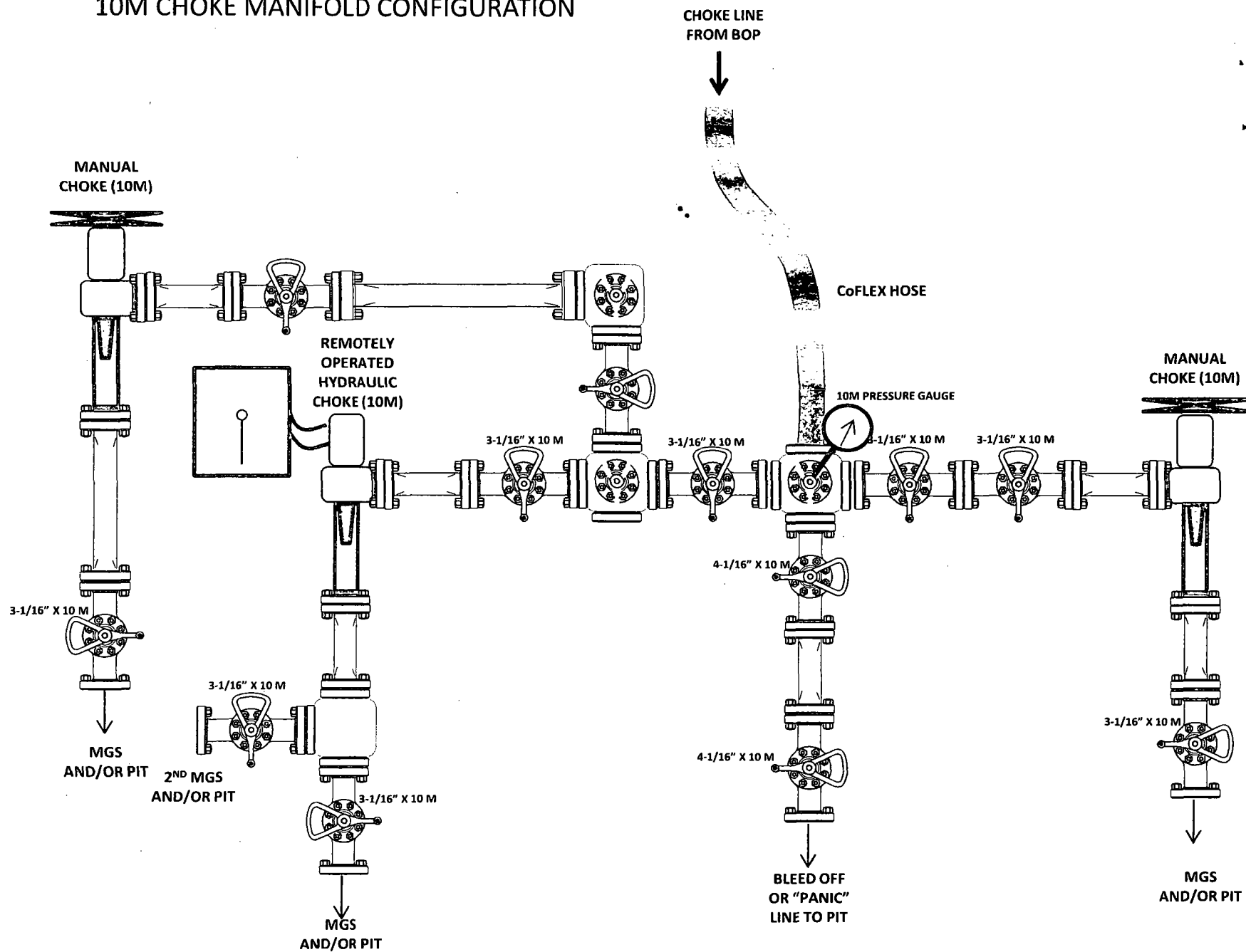
## 10M REMOTE KILL SCHEMATIC

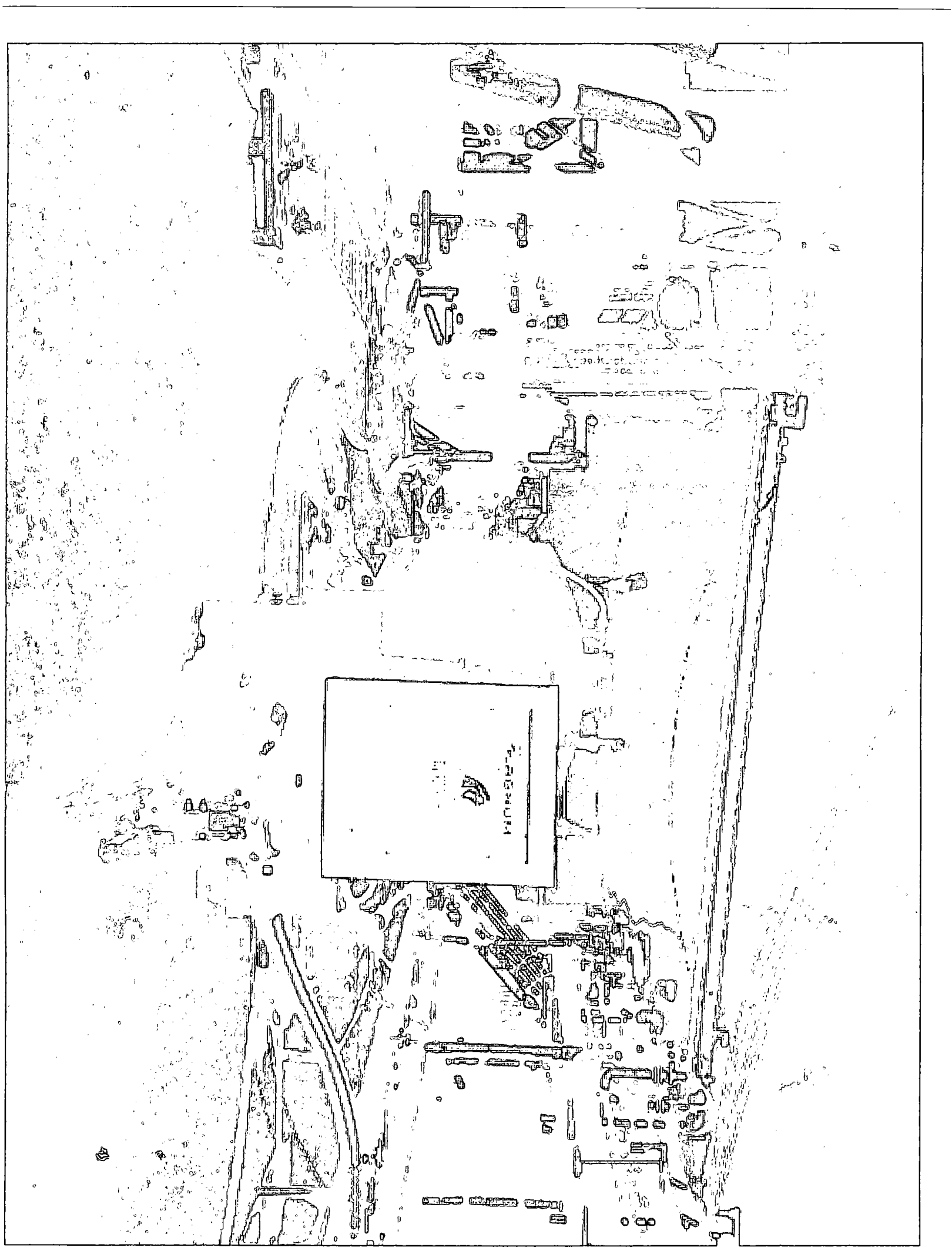




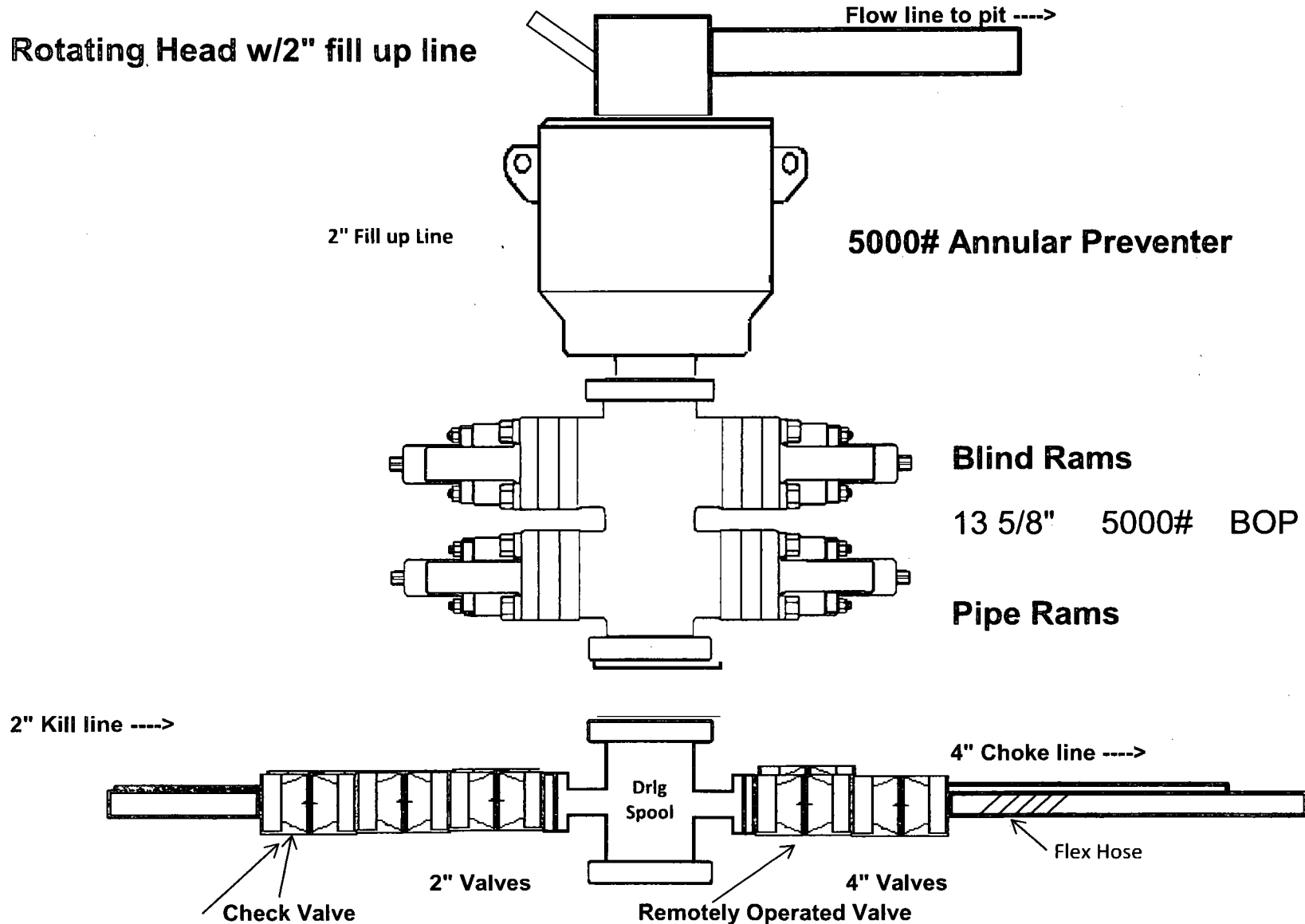








# 5,000 psi BOP Schematic
