The gas line will be approximately 1,502.0 feet long and 30 feet wide.

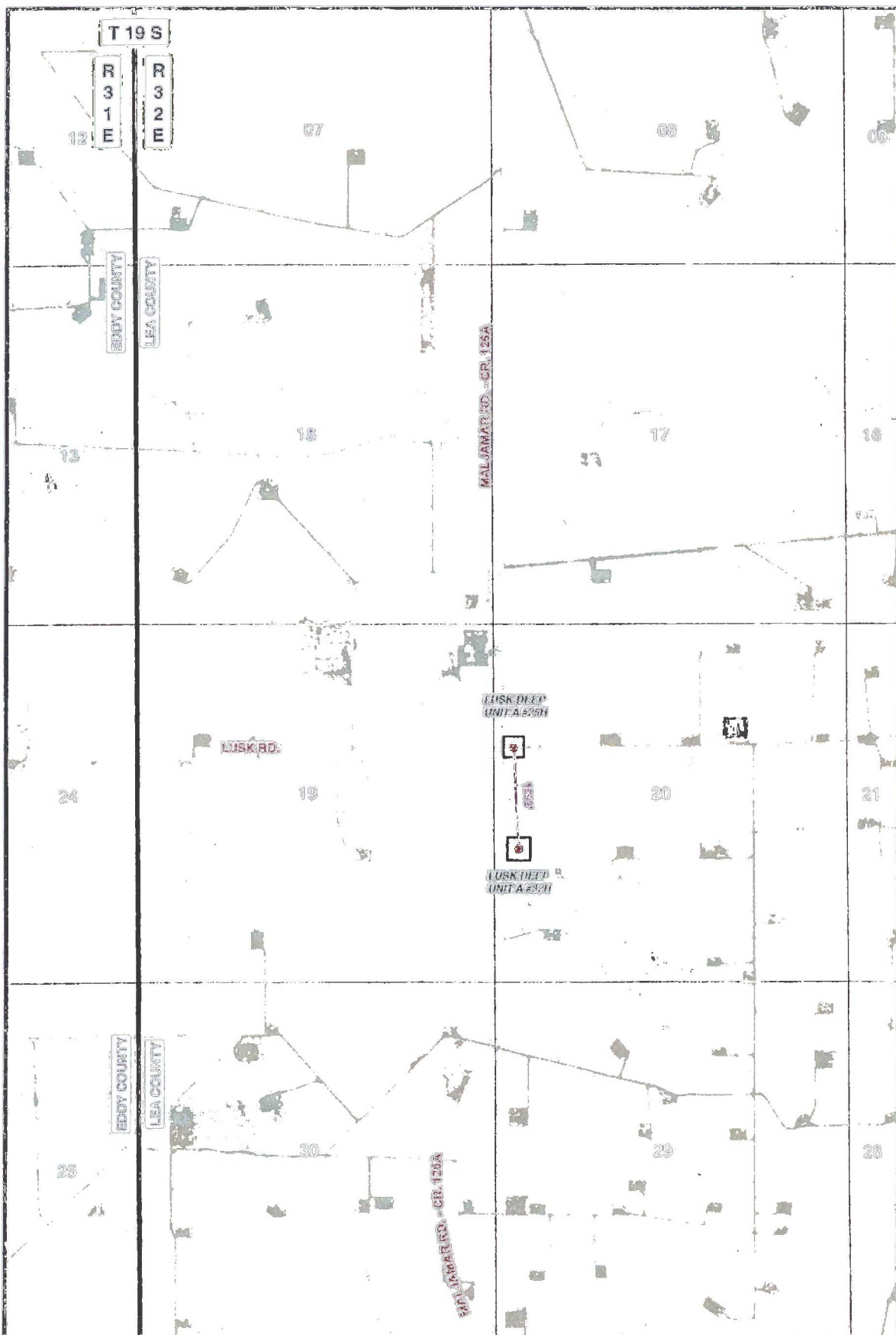
